I refer to your application pursuant to the *Freedom of Information Act 1991* (the Act) received by the Department for Environment and Water (DEW) on 23 November 2021, seeking access to:

"Copies of all credit card statements for credit cards held by all Executive Assistants/Personal Assistants in the Office of Chief Executive for the Department for Environment and Water. Copies of all documents and records including but not limited to financial statements, bank statements, credit card statements, briefings, minutes, correspondence, reports, emails, receipts, letters, and written notes of reimbursements paid to the Chief Executive of the Department for Environment and Water.

Timeframe: 25/03/2018 to 23/11/2021".

Section 19(2a) of the FOI Act, provides that an agency may give access to a document on an application after the period within which it was required to deal with the application (and any such determination is to be taken to have been made under this Act).

## **DETERMINATION**

Searches of the DEW's records have found one (1) document held by this agency within scope of your request.

I can confirm DEW does not hold any documents in relation to reimbursements paid to the Chief Executive of DEW.

As a DEW Accredited FOI Officer, I have determined to grant you full access to this document.
