	8.1	<p>All Souls Anglican Church, Lot 910 Stephens Terrace, St Peters. On Kurna Country.</p> <p><i>On 5 September 2024, the Council provisionally entered All Souls' Anglican Church in the SA Heritage Register as a State Heritage Place as it met criterion (e) under s16 of the Heritage Places Act 1993. No submissions were received during the consultation period. The Council will determine whether to confirm this place in the SA Heritage Register or remove the place from the SA Heritage Register.</i></p>
	8.2	<p>Christ Church Uniting (Church), 26 King William Road, Wayville. On Kurna Country.</p> <p><i>On 12 December 2024, the Council provisionally entered Christ Church Uniting (church), in the SA Heritage Register as a State Heritage Place, as it met criteria (e) and (g) under s16 of the Heritage Places Act 1993. No submissions were received during the consultation period. The Council will determine whether to confirm this place in the SA Heritage Register or remove the place from the SA Heritage Register.</i></p>
	8.3	<p>Former American River Methodist Church, 24 Ryberg Road, American River. On Ngarrindjeri, Ramindjeri, Kurna and Narungga Country.</p> <p><i>On 14 November 2024, the Council provisionally entered the Former American River Methodist Church in the SA Heritage Register as a State Heritage Place as it met criterion (e) under s16 of the Heritage Places Act 1993. No submissions were received during the public consultation period. The Council will determine whether to confirm this place in the SA Heritage Register or remove the place from the SA Heritage Register.</i></p>
	8.4	<p>Former Elizabeth South Methodist Church Hall, 114 Harvey Road, Elizabeth Grove. On Kurna Country.</p> <p><i>On 12 December 2024, the Council provisionally entered the Former Elizabeth South Methodist Church Hall in the SA Heritage</i></p>

		<i>Register as a State Heritage Place as it met criterion (a) under s16 of the Heritage Places Act 1993. One submission was received. The Council will determine whether to confirm this place in the SA Heritage Register or remove the place from the SA Heritage Register.</i>
	8.5	<p>Jean Flynn Presbyterian Church, 106 Goodman Road, Elizabeth South. On Kaurna Country.</p> <p><i>On 12 December 2024, the Council provisionally entered Jean Flynn Presbyterian Church in the South Australian Heritage Register (the Register) as a State Heritage Place as it meets criterion (a) under s16 of the Heritage Places Act 1993. No submissions were received. The Council will determine whether to confirm this place in the SA Heritage Register or remove the place from the SA Heritage Register.</i></p>
	8.6	<p>Munro Karst, Hynam Caves Road, Mount Light. On First Nations of the South East Country.</p> <p><i>On 23 August 2024, the Deputy Chair, under delegated authority, provisionally entered and designated this place as a place of speleological significance under sections 17(2)(b) and 14(7)(a) of the Heritage Places Act 1993. This triggered three months of public consultation. One submission was received. The Council will consider the submission, and then determine whether to confirm this place in the SA Heritage Register or remove the place from the SA Heritage Register.</i></p>
	8.7	<p>Torrens Island Quarantine Station Collection of Objects. Grand Trunkway, Torrens Island. On Kaurna Country.</p> <p><i>On 5 September 2024, this place was confirmed as a State Heritage Place. At this meeting, the Council will consider listing a collection of objects associated with the place.</i></p>
9	ITEMS TO BE CONSIDERED FOR DESIGNATION	
	9.1	<p>Wilkawillina Archaeocyatha Site, Flinders Ranges. On Adnyamathanha Country.</p> <p><i>This place was listed as a State Heritage Place on 19 August 1993. At this meeting the Council will consider any submissions received during the three-month consultation period in relation to the designation of the place. The Council will either retain or revoke the designation.</i></p>
10	ITEMS FOR REVISION	
	10.1	<p>Green Water Tank Cave, (L81), Allotment 550, Princes Highway, Tantanoola. On Boandik Country.</p> <p><i>This place was confirmed and designated as a State Heritage Place on 23 June 2022. At this meeting the Council will consider the extent of the listing.</i></p>
	10.2	<p>Mount Wudinna & Environs (Mt Wudinna, Little Wudinna, Pold Rock & Turtle Rock). On Barnjarla, Kokatha and Wirangu Country.</p>

		<i>This place was confirmed as a State Heritage Place on 16 March 2000. At this meeting the Council will consider the extent of the listing.</i>
