I refer to your application pursuant to the *Freedom of Information Act 1991* (the Act) received by the Department for Environment and Water (DEW) on 19 June 2018, seeking access to:

- "1. Wombat Destruction permits issued for properties in the Hundred of Julia Creek.
- 2. Wombat Destruction permits issued for properties in the suburbs of St Kitts and Bagot Well in the Hundred of Belvidere and Hundred of Kapunda.

TIMEFRAME: 1 January 2000 to 19 June 2018."

As advised via email on 28 June 2018, the Principal Officer of the agency determined to extend the time in which to respond to this application by 40 days to Wednesday, 29 August 2018, as permitted by Section 14A(1)(b) of the Act.

DETERMINATION

Searches of the Department's records have found a document listing 42 permits issued within scope of your request.

As a DEW Accredited FOI Officer, I have determined to grant you partial access to this document. Section 20 of the Act provides that an agency may refuse access to a document if it is an exempt document under the Act.

Parts of the document to which I am refusing access and the reasons for the refusal are explained in more detail below.

I also wish to advise you that searches of the Department's records have found no permits for the destruction of Southern Hairy-Nosed Wombats which are held by this agency that have been issued within the Hundred of Kapunda for this requested timeframe.

Document number 1

Schedule 1, Clause 6(1) of the Act states that:

6—Documents affecting personal affairs

6(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).

The full release of this document would involve the unreasonable disclosure of information concerning personal affairs, thus those parts are exempt pursuant to Clause 6(1) of the FOI Act.
