Dear Mr Brown

I refer to your application pursuant to the *Freedom of Information Act 1991* (the Act) received by the Office of the Minister for Environment and Water, on 7 December 2018, seeking access to:

*"All documents (including but not limited to reports, briefings, emails, notes, minutes, plans and other documents) mentioning or related to the areas of Para Hills, Para Hills West, Parafield, Parafield Gardens, Mawson Lakes or Greenfields."*

**DETERMINATION**

I note the discussions and correspondence between myself and your office regarding the exclusion of 'documents available to the general public' and 'documents relating to correspondence with Mr Brown/Playford Electorate Office'.

As per the discussions and correspondence I have had with your office and the abovementioned exclusions, searches of the records of this agency have found one (2) documents with content within scope of your request.

As the Accredited FOI Officer, I have determined to grant you full access to one (1) of the discovered documents that fall within the scope of your application (attached). Additionally I have determined to refuse access to one (1) of the documents that fall within the scope of your application.

Section 20(1)(a) of the Act provides that an agency may refuse access to a document if it is an exempt document. I have determined that the document to which access is refused is an exempt document pursuant to Schedule 1, clause 17(c) of the Act, which states a document is an exempt document if it contains matter the public disclosure of which would, but for any immunity of the Crown infringe the privilege of Parliament.

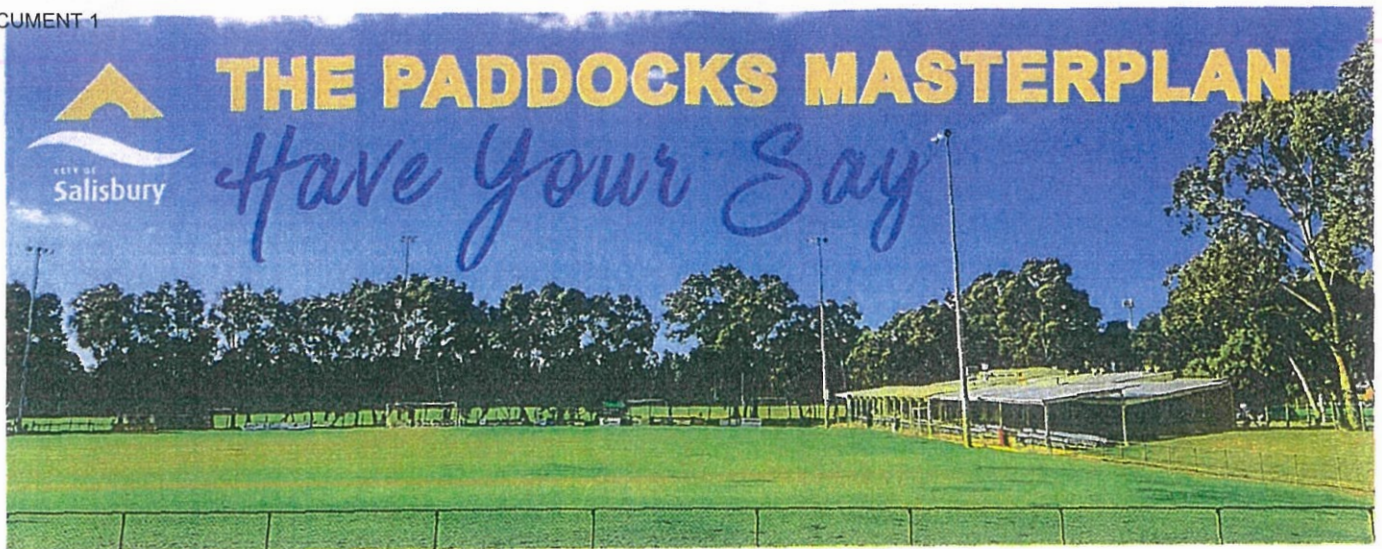
