# Dear Mr Maher

I refer to your application pursuant to the *Freedom of Information Act 1991* (the Act) received by the Office of the Minister for Environment and Water, on 13 December 2018, seeking access to:

"Since 17 March 2018, copies of any and all documents (including but not limited to physical, electronic, or written briefs, minutes, emails, internal correspondence and any other correspondence) regarding the Aboriginal Affairs Action Plan."

#### **DETERMINATION**

Searches of the agency records have found nine (9) documents held by this agency within scope of your request.

As the Accredited FOI Officer, I have determined to grant you full access to one (1) document, and refuse access to eight (8) documents.

Section 20 of the Act provides that an agency may refuse access to a document if it is an exempt document under the Act. The documents to which I am refusing access and the reasons for the refusal are summarised:

## Document numbers 1, 2, 3, 4, 5, 6, 7 and 8

Schedule 1, Clause 1(1) of the Act states:

#### 1 -Cabinet Documents

- (1) A document is an exempt document-
  - (a) if it is a document that has been specifically prepared for submission to Cabinet (whether or not it has been so submitted);
  - (b) if it is a preliminary draft of a document referred to in paragraph (a);or
  - (c) if it is a document that is a copy of or part of, or contains an extract from, a document referred to in paragraph (a) or (b); or
  - (e) if it contains matter the disclosure of which would disclose information concerning any deliberation or decision of Cabinet; or
  - (f) if it is a briefing paper specifically prepared for the use of a Minister in relation to a matter submitted, or proposed to be submitted to Cabinet.

Documents 1, 2, 3, 4, 5 and 6 include matters relating to cabinet business the disclosure of which would disclose information concerning deliberations of Cabinet, therefore documents these are exempt and documents pursuant to Schedule 1, Clause 1(1)(e) of the Act.

Documents **7** and **8** are documents specifically prepared for submission to Cabinet and are exempt in full pursuant to Schedule 1, Clause 1(1)(a) of the Act.
