I refer to your application pursuant to the *Freedom of Information Act 1991* (the FOI Act) received by the Office of the Minister for Environment and Water, on 14 February 2019, seeking access to:

"All documents, minutes, briefings, emails, notes and agendas relating to meetings between the Minister for Environment and Water and SA Water."

DETERMINATION

On 28 February 2019 I emailed you regarding this request and informed you that I have partially transferred the application as the documents you seek are more closely aligned to SA Water. However, I also stated that to ensure all documents are considered, I did not fully transfer your application to this office and that I would continue to discover and determine documents not held by SA Water.

As the agency did not determine the application within 30 days of receiving it, by the operation of section 19(2)(b) of the FOI Act, the agency is taken to have determined the application by refusing access.

However, section 19(2a) of the FOI Act, provides that an agency may give access to a document on an application after the period within which it was required to deal with the application (and any such determination is to be taken to have been made under the FOI Act).

Noting the above, I have identified 18 documents within the scope of your application and I have determined to;

- grant full access to 9 documents
- grant partial access to 9 documents.

Section 20(4) of the FOI Act provides that if it is practicable to give access to a copy of a document with exempt matter deleted, and it appears that the applicant would wish to be given such a copy, the agency must give access to a copy of the document to this limited extent. Therefore, I have determined to grant you partial access to these documents and to refuse you access to the remaining parts of the documents I consider to be exempt.

Pursuant to Clause 6 of the Act I have redacted matters the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of a person. In this instance, I have refused access to personal email addresses and phone numbers.

FEES AND CHARGES

There is no charge for processing this application.

YOUR APPEAL RIGHTS

If you are dissatisfied with this determination, you are entitled to exercise your rights to internal review and appeal as outlined in the attached documentation, by completing the attached Application for Review of Determination. If you decide to apply to exercise your rights to review, the completed form must be returned within 30 days to:

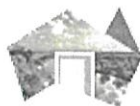
