'Growing Our Heritage Future' is a 10-year strategy for growing heritage tourism in South Australia. It provides guidance to the tourism industry, state and local government, Traditional Owners, regional organisations and local communities, and heritage owners, operators, custodians on how to leverage this potential.</i>
6	<b>ITEMS TO BE CONSIDERED FOR PROVISIONAL ENTRY ON THE SA HERITAGE REGISTER</b>
6.1	<u>Item relating to the whole of the West End Brewery nomination</u>  West End Brewery, Port Road, Thebarton  <i>This place has been nominated by a member of the public and Council will consider the nomination and determine whether it meets any of the criteria to be provisionally entered as a State Heritage Place.</i>
6.2	<u>Item relating to the whole of the West End Brewery nomination</u>  Object – Copper Kettle (associated with West End Brewery)  <i>The Council may include as part of the South Australian Heritage Register any object that is, in the opinion of the Council, an object of heritage significance. The Council will consider listing the Copper Kettle, on the proviso that it has made a listing under Item 6.1. An object can only be listed if it is intrinsically related to a State Heritage Place or Area.</i>

6.3	<p><u>Item relating to the whole of the West End Brewery nomination</u></p> <p>Remains of Theberton Hall Colonel Lights House (including underground room, tank and well) Port Road, Thebarton (corner of historic Cawthorne and Winwood streets).</p> <p><i>A separate assessment report has been prepared for the remains of Theberton Hall for Council's consideration.</i></p>
6.4	<p>Our Lady of Mount Carmel Church, 15 Pennington Terrace, Pennington</p> <p><i>This place was identified by the Council for assessment. The Council will consider an assessment report and determine whether it meets any of the criteria to be provisionally entered as a State Heritage Place.</i></p>

7.1	<p>Martindale Hall Billiards &amp; Sporting Collection</p> <p><i>On 10 December 2020, the Council provisionally entered the Billiards &amp; Sporting Collection as a State Heritage Object in the South Australian Heritage Register as it was found to be intrinsically related to the heritage significance of Martindale Hall under s16(2)(c) of the Heritage Places Act 1993. At this meeting, the Council will consider any submissions made by the owner and determine whether to confirm the collection in the South Australian Heritage Register.</i></p>
7.2	<p>Martindale Hall Pictorial Collection</p> <p><i>On 10 December 2020, the Council provisionally entered the Pictorial Collection as a State Heritage Object in the South Australian Heritage Register as it was found to be intrinsically related to the heritage significance of Martindale Hall (s16(2)(c) of the Heritage Places Act 1993. At this meeting, the Council will consider any submissions made by the owner and determine whether to confirm the collection in the South Australian Heritage Register.</i></p>
7.3	<p>Martindale Hall Heraldic Collection</p> <p><i>On 10 December 2020, the Council provisionally entered the Heraldic Collection as a State Heritage Object in the South Australian Heritage Register as it was found to be intrinsically related to the heritage significance of Martindale Hall (s16(2)(c) of the Heritage Places Act 1993. At this meeting, the Council will consider any submissions made by the owner and determine whether to confirm the collection in the South Australian Heritage Register.</i></p>
7.4	<p>Cummins House Furniture Collection</p> <p><i>On 16 July 2020, the Council provisionally entered the Cummins House Furniture Collection as twenty-one individual State Heritage Objects in the South Australian Heritage Register, as the objects were found under s16(2)(c) of the Heritage Places Act 1993 to be intrinsically related to the heritage significance of Cummins House. At this meeting, the Council will consider any submissions made by the owner and determine whether to confirm the collection in the South Australian Heritage Register.</i></p>
