Purpose

The purpose of the meeting is for Adnyamathanha common law holders to be consulted with and provide their consent to the Flinders Ranges being assessed for World Heritage.

Who can attend?

This meeting is open to all Adnyamathanha Common Law Holders, being those living Aboriginal people who:

(a) are the descendants (whether biologically or by adoption) of the following apical ancestors:

- i. Mt Serle Bob
- ii. Polly, wife of Mt Serle Bob
- iii. Quartpot Tommy
- iv. Mt Serle Bob's sister, wife of Quartpot Tommy
- v. Willy Austin Snr
- vi. Nicholas Demell
- vii. Emily McKenzie, wife of Nicholas Demell
- viii. Sydney Ryan
- ix. Mary, wife of Sydney Ryan
- x. the siblings Angepena Billy or Mary
- xi. Fanny, wife of Angepena Billy
- xii. the siblings Sara Johnson, Matilda Johnson, Fred Johnson, Natalie Johnson, Jessie Johnson or Sydney Jackson, and

(b) identify as Adnyamathanha; and

(c) are recognised by other Native Title Holders under the relevant Adnyamathanha traditional laws and customs as having maintained an affiliation with and continuing to hold native title rights and interests in, the Determination Area.

The meeting will be attended and facilitated by the Department for Environment and Water, Terry Bailey (World Heritage expert) and Moore Australia. The Special Administrator and representatives of ORIC will not be in attendance.

What decisions will be considered at this meeting?

Adnyamathanha common law holders will be asked to consider and provide their consent to:

1. the Flinders Ranges being assessed for World Heritage based on its fossil record under a natural (geological) criterion.

This notice contains important information about the meeting. It sets out the business of the meeting and the decisions that Common Law Holders will be asked to make at the meeting. Members should read all of this notice.

Venues

1. There are 3 physical venues for attending the meeting, and Common Law Holders may also attend via video link.
 - The meeting will run at all three venues at the same time with all three venues being connected via video link.
 - The Chief Executive Officer of Reconciliation South Australia will chair the meeting.
 - Representatives of the Department for Environment and Water and Terry Bailey (World Heritage expert) will be present at all 3 locations and support the presentation of the Flinders Ranges World Heritage project.
 - Moore Australia staff will be present at all 3 locations and help run the meeting.
 - The Special Administrator and ORIC will not attend the meeting.

Registration

2. On arrival at the meeting, Common Law Holders should proceed to the registration desk and confirm their name, address and any other details.
3. Common Law Holders should sign next to their name on the register to record their attendance and receive a voting card.

Voting

4. Common Law Holders must be at one of the three physical locations to vote. Voting is not available to online attendees.
5. Voting by proxy is not permitted for Common Law Holders meetings.

Quorum

6. There is no quorum requirement for Common Law Holders meetings.

7. Each Common Law Holder has 1 vote.
8. Only the business set out in this notice can be decided at the meeting. This is so that all members have notice of the business that will be considered and information that helps them decide how to vote at the meeting.

 - “ORIC” means the Office of the Registrar of Indigenous Corporations.
