Communique - 11 August 2025

The Coorong, Lower Lakes and Murray Mouth (CLLMM) Community Advisory Panel (CAP) met on Ngarrindjeri Country at the Langhorne Creek Bowls Club on 11 August 2025.

Welcome and introductions

The Chair opened the meeting and welcomed the following 9 new members to the CAP, marking the first meeting under the revised <u>Terms of Refence</u>.

Department for Environment and Water (DEW) Executive Director, Water and River Murray Sue Hutchings extended a warm welcome to all members and acknowledged the valuable contributions CAP volunteers make to both the community and the department.

Overview of CAP and agency roles

Members received a briefing on the CAP's role and how various stakeholders contribute to its objective, including an overview and updates from:

- Commonwealth Environmental Water Holder (CEWH)
- Landscapes SA
- Goyder Institute CLLMM Research Centre
- Murray-Darling Basin Authority (MDBA)

DEW program leaders provided an overview of the role the department fulfills in the CLLMM region, through functions such as infrastructure and operations, water delivery and environmental water, and emphasised the importance of work through scientific and First Nations partnerships.

Algal bloom update

Members were provided an update on the *Karenia mikimotoi* algal bloom affecting South Australian coastal areas and the Coorong. Sue Hutchings outlined the \$28 million response package from the Government of South Australia and the role of the inter-agency Harmful Algal Bloom Taskforce.

Members were briefed on the latest scientific understanding of the bloom, monitoring efforts in the Coorong and where to access publicly available information, including:
