A lessee must complete this application form when requesting a **CHANGE OF PASTORAL LAND USE**. **If you have more than one lease, the form must correctly detail each lease/s for the change of pastoral land use.**

Section 22(6)(c) and (d) of the *Pastoral Land Management and Conservation Act 1989* allows the Pastoral Board to approve the use of pastoral land for other purposes. All proposals for other purposes to occur on pastoral lease land must be submitted to the Board for approval.

With Board approval a pastoral lease's primary use can be either pastoral or conservation purposes, and other land uses can occur concurrently with either primary purpose, however separate approval from the Board is required. Other land uses may include but are not limited to:

- Conservation (on a portion of a lease in conjunction with pastoral purposes)
- Carbon farming
- Tourism
- Telecommunications infrastructure
- Workers camps
- Small scale renewable energy projects (projects under 5MW)
- Miscellaneous

This form must be signed personally by the applicant(s) or, if a company, in accordance with section 127 of the *Corporations Act 2001* regarding authorised signatories. If a third party is making application, written consent from the registered lessee must be provided.
