I refer to your application under the Freedom of Information Act 1991 (the Act) received by the Department for Environment and Water (DEW) on 5 October 2022, seeking access to:

"A list of any internal DEW operational policies and procedures that have been updated between 29 March 2022 and 4 October 2022."

The statutory due date of this application lapsed on 5 November 2022. In accordance with section 19(2)(b) of the Act, if a determination is not made within 30 days, the agency is to be taken to have determined the application by refusing access to the document. An agency is permitted to make a late determination, as was the intention for this application.

On 9 November 2022, DEW received your application for an internal review of your FOI application DEW22-075. The statutory due date for determining the internal review is 23 November 2022.
