## Application to lapse caveat registered without the express consent of the water licence holder

Pursuant to Schedule 4 Clause 14 of the *Landscape South Australia Act 2019* and regulation 23 of the *Landscape South Australia (Water Register) Regulations 2020*

Pursuant to regulation 23 of the *Landscape South Australia (Water Register) Regulations 2020* (the Regulations):

- This application relates to the registration of a caveat under regulation 20 of the Regulations, where the application has been made without the express consent of the water licence/water access entitlement holder.
- The holder of the water licence/water access entitlement has been given notice of registration of the caveat under regulation 20(6) of the Regulations and has been provided with advice about the options available to remove the caveat.
- The holder of the water licence wishes to lapse the caveat under regulation 23(2) of the Regulations.
- The Minister must give notice of this application to the caveator. The caveat will lapse at the expiry of 21 days after service of the notice on the caveator unless the caveator both obtains an order of the Environment, Resources and Development Court under regulation 25 that provides that the caveat should continue to be registered, and provides that order to the Minister.

*A person who furnishes information to the Minister or another authority under the Landscape South Australia Act 2019 that is false or misleading in a material particular is guilty of an offence. Maximum penalty: \$20 000.*
