		<p>On 1 March 2023, a member of the public nominated Daweslee Cottage for listing as a State Heritage Place in the South Australian Heritage Register as they believe it satisfies criteria (e) and (g) under s16(1) of the Act. At this meeting, the Council will consider the nomination and an assessment report and determine whether this place meets the threshold for provisional entry in the South Australian Heritage Register as a State Heritage Place.</p>
	8.2	<p>Neighbour House, 61 Braemar Road, Torrens Park. On Kaurna Country.</p> <p><i>On 10 April 2025, the Council approved a 'flexible approach' to the 'prioritisation of assessment' of a number of places from 1945-1999. Neighbour House was one of these places. An Assessment of this place suggests that the place satisfies criteria (e) and (g) under s16(1) of the Act for registration as a State Heritage Place. At this meeting, the Council will consider the assessment and determine whether it meets the threshold for provisional entry in the South Australian Heritage Register as a State Heritage Place.</i></p>
