From the Chair, Professor Robert Hill



The core work of Koala Life has continued to develop, centred around the insurance colony of koalas held at Cleland Wildlife Park and the vital genetic management and breeding of future generations for possible reintroduction to a wild in which koalas may have disappeared. As a research-based, not for profit organisation, dedicated to koala conservation, Koala Life has established key partnerships with government agencies,

academic institutions, philanthropic and business leaders, and the wider community.

The last year has been eventful for Koala Life as breeding has continued with the colony of conservation study koalas at Cleland Wildlife Park. Genetic results are pending on the genetic profiles of the Strzelecki fathers, Kangaroo Island mothers and first generation offspring and verbal reports suggest that there *is* a genetic difference. This will demonstrate that this exercise in contained genetic management of a small group of captive koalas has been successful and acts as a demonstration or pilot for possible larger scale breeding and conservation management in the future.

Research into disease and genetic techniques is ongoing and relatively long term and findings will certainly inform decisions within evolving national and state koala management approaches.

An area of new activity has been in public engagement, simply put to tell the story of koalas and their conservation spanning ancient aboriginal insights into koalas and their gum forest homes, through the arrival of Europeans, the previous huge population collapse in the early 1900's due to fur trading, to the modern day onslaught on their habitats, disease spread and wildfire impacts. Crucially, this story development involves Aboriginal voices and includes Nature Play principles and will inform and inspire people to care and action.

There are linkages with the planting of thousands of gum trees across the Mt Lofty region as part of a collaborative initiative supported by Dr Jane Goodall during her visit to Koala Life and Cleland Wildlife Park this year.

The contribution of an energetic Board has been invaluable and the transition to a volunteer board is a demonstration of commitment.




The International Koala Centre of Excellence is a body corporate established as a subsidiary of the Minister for Climate, Environment and Water, the Hon Susan Close MP.


Ms Close is the Deputy Premier and oversees a group of portfolio agencies including the Department for Environment and Water.

The agency's performance

Performance at a glance

The Strzelecki males and Kangaroo Island females were mated in 2022 and early 2023. The Board is now waiting on confirmation of the success of this breeding event.

Over 3,000 gum saplings have been planted for renewal of the shared Cleland Wildlife Park and Koala Life plantations established to feed koalas at the Cleland. Land is being offered for this purpose by a growing number of partners spanning a range of land ownership models.

Peer reviewed research publications have been written on aspects of stress monitoring and disease management with colleagues from our two closest University partners, Flinders and Adelaide. Research discussions are ongoing with a number of interstate universities, within the context of the CSIRO led national koala recovery plan, with a view to exploring significant grant funding.

Opportunities to engage, create awareness and collaborate were maximised in 2024 with the highlight being a visit from Dr Jane Goodall a global icon in nature. Koala Life hosted 90 people at a Youth Voice Event inspired by Dr Jane Goodall in her 90th year.

Youth Voice and Forests of Hope was launched in partnership with Arborgreen and Scouts SA that will see 90 trees planted across 90 locations providing habitat and food for our Koalas and wildlife. Koala Life is continuing its partnership with Green Adelaide to further advocate for young leaders in the environment field, following from it's successful engagement with Dr Jane Goodall on the Youth Voice for the Environment Initiative.

They will support young leaders to lead and activate the collective and build relationships with existing and new partners, ambassadors, and emerging interest groups. The collective will host an annual *Youth Voice Statement for the Environment*.

A summary report from the youth engagement process undertaken for the Jane Goodall event is underway and will inform the intent of this year's Statement.
