5.3.1 Planning and Design Code Amendment – draft Board Submission

A Broom presented the Planning and Design Code Amendment – draft Board Submission. A Broom provided a breakdown of the four key issues raised, including proposed amendments to the Coastal Areas Overlay and Coastal Flooding Overlay to ensure development addresses the Board's sea level rise allowance; that land division in the Rural Shack Settlement Zone remain as a "restricted" form of development; and that the Aquaculture General Development Module not include certain Deemed to Satisfy provisions to ensure the Board's role as a prescribed referral body is not compromised.

Note the Miscellaneous Technical Enhancement (MTE) Planning and Design Code (Code) Amendment. **Endorse** the draft Coast Protection Board submission to the MTE Code Amendment (Attachment 1). **Review** the DEW submission out-of-session for information.

- b. \$7,000 to Priority Project 3 Review of Grant Programs.
- c. \$17,000 to Priority Project 5 Review of Board Policy Document.

Approve the re-assignment of the Eyre Peninsula Saltmarsh Profile Surveys in the 2022-23 Budget from Grants – Other Grants to Projects – Monitoring.
