

SECTOR AGREEMENT

For the Northern and Yorke Region PURSUANT to the *Climate Change and Greenhouse Emissions Reduction Act 2007*

and

THE GOVERNMENT OF SOUTH AUSTRALIA



THIS AGREEMENT is made the day of 2021

BETWEEN

- (1) The Minister for Environment and Water (the Minister) on behalf of the Government of South Australia
- and
- (2) The Northern and Yorke Alliance, as represented by the following partners: Legatus Group, Northern and Yorke Landscape Board, Regional Development Australia Yorke and Mid North and Regional Development Australia Barossa Gawler Light Adelaide Plains.

The partners listed under (2) are jointly referred to as the 'Northern and Yorke Alliance'. The Legatus Group is the trading name of the Central Local Government Region of South Australia and undertakes the co-ordination, advocacy and representation of the 14 constituent councils across the Region.

It is acknowledged that other entities (from both the public and private sectors) within the region may become partners to this Agreement in the future, as implementation proceeds. If this eventuates, this Sector Agreement (Agreement) may be reviewed and amended accordingly.

This Agreement builds on the previous *Yorke and Mid North Regional Sector Agreement*, which was signed on 3 November 2017 and expired on 30 June 2020.

STATEMENT OF PURPOSE

This Sector Agreement (the Agreement) between the Government of South Australia and the Northern and Yorke Alliance formalises leadership and acknowledges the importance of cooperative work between the signatories in responding to climate change and sustainability.

The members of the Northern and Yorke Alliance have a common goal to improve the resilience of their communities, assets and infrastructure, local economies and natural environment so that they can cope with the inevitable impacts and challenges of climate change in the short, medium and long term, through the implementation of the 2013 *Yorke and Mid North Regional Climate Change Action Plan* and the *Adapting to Change – Forming New Habits: Climate Change Adaptation Plan for the RDA Barossa Region* (these are referred to as the Plans).

This Agreement:

- Articulates a common goal amongst the signatory parties to implement climate change adaptation actions, as resources allow, in a cooperative, coordinated and consultative manner in the region; and
- Has, as its key focus, adaptation and response to the impacts, risks, and opportunities of climate change in the Region - to be addressed as per the identified priorities from the Plans via:
 - setting agreed objectives
 - cooperatively identifying and progressing partnership opportunities across sectors within the Region
 - committing to report on delivery of the Plans
 - cooperating in the implementation of the Plans, including their ongoing evaluation and review

- acknowledging that the identified priorities from the Plans also align with, and help support state-wide priorities and policy directions as outlined in this Agreement.

THE REGION

The Region includes the Northern and Yorke Landscape Board region. This encompasses the Yorke Peninsula, significant areas of Spencer Gulf and Gulf St Vincent, the southern Flinders Ranges, parts of the Rangelands, the Mid North, the northern Mount Lofty Ranges, the Barossa and northern Adelaide Plains. The Northern and Yorke region extends for 38,500 square kilometers. It is a varied and productive portion of South Australia and includes approximately 1,300km of coastline and adjacent marine areas.

The Region includes the traditional Aboriginal lands of the Narrunga, Nukunu, Ngadjuri, Kaurna and Peramangk people. Climate projections for the Region indicate that average temperatures will increase across seasons, and will result in more hot days, fewer frosts, and harsher fire-weather. Projections also indicate that the region will see a decrease in winter rainfall, but an increase in the intensity of extreme rainfall events. Sea level rise will continue to increase, as will the height of extreme sea-level events.

1 GUIDING PRINCIPLES

- 1.1 This Agreement acknowledges a joint commitment on the part of the Northern and Yorke Alliance and the Government of South Australia to respond to climate change by focusing on adaptation and identifying the economic, environmental, and social opportunities for the Region.
- 1.2 This Agreement will be guided by a high-level integrated approach whereby all signatories provide strategic direction for the Region in tackling climate change in alignment with the Plans.
- 1.3 This Agreement acknowledges that the Northern and Yorke Alliance will endeavour to coordinate and implement actions and priorities as identified in Schedule 1, as resources allow.
- 1.4 The Agreement complements and supports existing policies and programs, including:
 - the Government of South Australia's [*Directions for a Climate Smart South Australia*](#) policy statement and priorities outlined in the [*South Australia's Climate Change Challenges and Opportunities*](#) report
 - the [*South Australian Government Climate Change Action Plan 2021-2025*](#)
 - [*Stronger Together – South Australia's Disaster Resilience Strategy*](#)
 - regional plans including those of the RDA Barossa Gawler Light Adelaide Plains, RDA Yorke Mid North, Legatus Group and Northern and Yorke Landscape Board
 - Northern and Yorke Coastal Management Action Plan, and
 - individual Council strategies that incorporate climate change mitigation and adaptation plans already in place.
- 1.5 The Northern and Yorke Alliance will work to identify common priorities and opportunities for collaboration to address the regional impacts, risks, and opportunities of climate change.
- 1.6 The Agreement and Schedule 1 support the achievement of the *Climate Change and Greenhouse Emissions Reduction Act 2007*, whilst assisting with the implementation of the Plans.

- 1.7 While specific responses to climate change may vary, this Agreement aims to facilitate a cooperative approach across the region to identify and address elements of common interest and benefit, recognising that responses may need to represent the risks to, or interests of, specific communities.

2 BACKGROUND

- 2.1 The Government of South Australia has enacted the *Climate Change and Greenhouse Emissions Reduction Act 2007* ("the Act"), which seeks to reduce greenhouse gas emissions within the State.
- 2.2 South Australia's Adaptation Framework (2012) assisted regions to develop strategies across the State to deal with climate change impacts and potentially benefit from opportunities presented by climate change.
- 2.3 The Government of South Australia's *Directions for a Climate Smart South Australia* policy statement includes a policy direction for the state government to support South Australian communities, industries, businesses and the environment to manage risk, harness opportunities, adapt and build resilience to climate change.
- 2.4 *South Australia's Climate Change Challenges and Opportunities* report released in September 2020 has informed the government's response on mitigation and adaptation including carbon farming, climate data and information, more efficient water use and adapting agriculture.
- 2.5 The *South Australian Government Climate Change Action Plan 2021 – 2025* describes government-led objectives and actions to help to build a strong, climate smart economy, further reduce greenhouse gas emissions, and support South Australia to adapt to a changing climate.
- 2.6 The Government of South Australia seeks to reduce greenhouse gas emissions and adapt to a changing climate within the State. The government aims for South Australian greenhouse gas emissions to be reduced by more than 50% below 2005 levels by 2030. The government is aiming to achieve net zero emissions by 2050.
- 2.7 The Government of South Australia and the Northern and Yorke Alliance are taking a collaborative approach to ensure the Region is resilient to the changes resulting from climate change, and to identify opportunities to enhance the Region's ongoing prosperity and quality of life in future.
- 2.8 The Yorke and Mid North Region completed the *Northern and Yorke Climate Change Action Plan* in August 2013 and has since been implementing its priorities, focusing on regional scale collaboration and preparedness in a changing climate. In February 2020 the *Emerging Themes for Drought Response and Climate Change Resilience Report* was completed which collated the key information about plans and projects that have occurred within the region in the past, identified past priorities and gaps that have not been addressed by drought or climate change works since 2011.
- 2.9 The *Adapting to Change – Forming New Habits Climate Change Adaptation Plan for the RDA Barossa Region* (the Barossa Adaptation Plan) was completed in 2015 and updated in 2020. The inclusion of the RDA Barossa as a partner of this Sector Agreement will ensure implementation of, and reporting on, the Barossa Adaptation Plan and *Northern and Yorke Climate Change Action Plan* will be inclusive of the whole Northern and Yorke region.
- 2.10 The Government of South Australia and the Northern and Yorke Alliance are entering into a Sector Agreement under the Act in order to:
- 2.10.1 recognise differences across the Region and facilitate geographically specific responses to climate change

- 2.10.2 work together to support a better understanding of climate change risks and issues for communities
- 2.10.3 facilitate community engagement and participation in programs designed to promote adaptation actions
- 2.10.4 explore the potential for joint projects and partnerships; and Australian Government and other funding opportunities, and
- 2.10.5 promote and showcase achievements as an example for other areas of South Australia, as well as nationally.
- 2.11 This Agreement and Schedule 1 identify actions to be undertaken by the parties to achieve outcomes within the areas of focus.

3 THIS SECTOR AGREEMENT DOES NOT CREATE LEGALLY BINDING OBLIGATIONS

- 3.1 This Agreement does not create any legally binding contract between the parties and does not give rise to any legally binding obligations.
- 3.2 The parties may amend any actions (as outlined in the Schedule 1) and commitments by written agreement at any time.

4 GOVERNANCE ARRANGEMENTS

- 4.1 A Committee will be formed to support the delivery of the schedules.
- 4.2 Membership of the Committee will include Chairs and CEOs from each of the partners of the Northern and Yorke Alliance and a representative from the Government of South Australia.
- 4.3 The Committee will provide regular progress reports to all signatory parties.
- 4.4 The Committee will appoint its own chairperson and determine its own meeting procedures and processes to resolve potential disputes and to manage potential conflicts of interest.
- 4.5 The Committee may, as approved by the Northern and Yorke Alliance, have observers at its meetings.
- 4.6 The Committee may establish sub-groups as required to support the specific objectives of this Agreement, the Plans and delivery of actions outlined in Schedule 1.
- 4.7 The South Australian government representative may provide regular briefings to the Committee on government policy developments, as required.
- 4.8 The Committee will review Schedule 1 annually, on anniversary of signing.

5 ROLES AND RESPONSIBILITIES

- 5.1 Pursuant to this Agreement, the Northern and Yorke Alliance undertake to:
 - 5.1.1 Participate in Committee activities.
 - 5.1.2 Endeavour to coordinate and implement actions and priorities as identified in Schedule 1, as resources allow.
 - 5.1.3 Ensure consistency of pursued climate change action with relevant Local, State and Australian government strategies and integration with broader regional / state / national climate adaptation plans.
 - 5.1.4 Ensure evidenced based approaches are incorporated into climate change adaptation planning and action along with balancing cultural considerations.

- 5.1.5 Contribute in a timely fashion to reviews of all key deliverables.
- 5.1.6 Promote the Plans' objectives internally and to relevant stakeholders.
- 5.1.7 Consult with First Nations peoples and give consideration to traditional owners' land protection and conservation practices that may be particularly beneficial for climate adaptation.
- 5.1.8 Prioritise opportunities to implement the Plans on a regional scale, rather than on a Council by Council basis, where it is efficient and practical to do so.
- 5.2 Pursuant to this Agreement, the Northern and Yorke Alliance partners will seek to identify funding for a hosted Regional Coordinator role with responsibility for:
 - 5.2.1 Project management of the operational and administrative needs of the Committee, including contractual obligations, management of any staff or consultants, reporting, project communications, scheduling, budgeting, and quality. The role shall operate under the broad direction of the Committee.
- 5.3 The Government of South Australia undertakes to:
 - 5.3.1 Participate in Committee activities.
 - 5.3.2 Promote relevant objectives and achievements internally and to relevant stakeholders.
 - 5.3.3 Collaborate on initiatives that support the Government's *Directions for a Climate Smart South Australia* and the *South Australian Government Climate Change Action Plan 2021 – 2025*, including exploring funding opportunities and sharing state-wide learnings regarding climate change response initiatives.
 - 5.3.4 Collaborate, as appropriate, to implement priority actions identified in the Barossa's Adaptation Plan (Schedule 3) and Northern and Yorke Climate Action Plan, and to support the climate change related work of the Northern and Yorke Landscape Board.
 - 5.3.5 Support, as appropriate, the development of any relevant funding proposals to the Australian Government or other funding bodies.
 - 5.3.6 Ensure that briefings and advice are provided to the Committee on state and national policy developments and discussions, as required and relevant to this Agreement.

6 DURATION OF THIS AGREEMENT


- 6.1 This Agreement shall continue from the date on which it is made until 30 June 2024.

- 6.3 This Agreement may be amended at any time if one party seeks to withdraw from the Agreement by providing 30 days written notice to the other signatory parties.
