I refer to your application pursuant to the *Freedom of Information Act 1991* (the Act) received by the Department for Environment and Water (DEW) on 02 February 2022, seeking access to:

"Minutes of meetings of the Native Vegetation Council Timeline: 04 November 2020 to 04 August 2021"

As the documents sought were not held by DEW but relate directly to the Native Vegetation Council, this Freedom of Information (FOI) application was transferred to the Native Vegetation Council to that agency on 17 February 2022 and you were advised by email accordingly.

On 17 February 2022 the scope was amended by agreement to:

"Documents concerning the Native Vegetation Council assessment of the Southern Launch, Whalers Way Orbital Launch Complex development including relevant Minutes of Native Vegetation Council meetings.

Timeline: between 4/11/2020 to 4/08/2021."

As the agency did not determine the application within 30 days of receiving it, by the operation of section 19(2)(b) of the FOI Act, the agency is taken to have determined the application by refusing access. Section 19(2a) of the FOI Act provides that an agency may give access to a document on an application after the period within which it was required to deal with the application (and any such determination is to be taken to have been made under this Act).

DETERMINATION

Searches of the Native Vegetation Council's records have found seven (7) documents (inclusive of attachments) held by this agency within scope of your request.

As Principal Officer, I have determined to grant you partial access to seven (7) documents.

Section 20 of the Act provides that an agency may refuse access to a document if it is an exempt document under the Act. The documents, or parts of the document to which I am refusing access, the reasons for the refusal and the public interest test are summarised in the attached document schedule. The FOI Act exemption clauses relevant to this determination are listed below for your reference.

Schedule 1, Clause 4(1)(a) of the Act states:

4— Documents affecting law enforcement and public safety

- (1) A document is an exempt document if it contains matter the disclosure of which could reasonably be expected—
 - (a) to endanger the life or physical safety of any person;

Schedule 1, Clause 6(1) of the Act states:

6—Documents affecting personal affairs

(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).

Schedule 1, Clause 7(1)(b) of the Act states:

7—Documents affecting business affairs

- (1) A document is an exempt document—
 - (b) if it contains matter—
 - (i) consisting of information (other than trade secrets) that has a commercial value to any agency or any other person; and (ii) the disclosure of which—
 - (A) could reasonably be expected to destroy or diminish the commercial value of the information; and
 - (B) would, on balance, be contrary to the public interest;

Schedule 1, Clause 9 of the Act states:

9—Internal working documents (1) A document is an exempt document if it contains matter—

- (a) that relates to—
 - (i) any opinion, advice or recommendation that has been obtained, prepared or recorded; or
 - (ii) any consultation or deliberation that has taken place, in the course of, or for the purpose of, the decision-making functions of the Government, a Minister or an agency;
- and (b) the disclosure of which would, on balance, be contrary to the public interest

As advised, information in documents not relevant to the scope of your application have been redacted.

The Council will provide the determination electronically.

In accordance with <u>PCO45 – Disclosure logs for Non-personal information</u> once a determination has been provided, the agency is required to make available on our website information and documents that have been disclosed. Information will be publicised online at https://www.environment.sa.gov.au/about-us/boards-and-committees/native-vegetation-council/nvc-foi-disclosure-log.

FEES AND CHARGES

There will be no further charges to process this application.

YOUR APPEAL RIGHTS

If you are dissatisfied with this determination, you have the right to apply for an external review. All applications for an external review should be made to the Ombudsman SA.

RECOMMENDATIONS

That the Native Vegetation Council:

- 1. Note the following information and associated presentation regarding the proposed Southern Launch Facility at Whalers Way;
- 2. Consider if the variation to the Heritage Agreement would be consider seriously at variance with the Principles of clearance under the Native Vegetation Act;
- 3. Determine if a variation to the Heritage Agreement (HA) would be supported by the Native Vegetation Council to enable the development to proceed.

BACKGROUND

Southern Launch is proposing to construct the Whalers Way Orbital Launch Complex on land located at the southern tip of the Eyre Peninsula, at Whalers Way, Sleaford.

Southern Launch is seeking to establish infrastructure that will support the launch of domestic and international launch vehicles providing Polar and Sun Synchronous Orbit satellite insertion.

Whalers Way has been identified as the preferred location of the launch complex through a review of potential locations across Australia.

The project has been declared as a major Development under the Subsection (1) of Section 46 of the *Development Act 1993*. For the purposes of the major development declaration, the development will include the following features:

- launch pads
- assembly facilities (both temporary and permanent)
- secure block houses, blast walls and firing bunkers
- lightning rods and anemometer towers
- propellant (liquid, hybrid and solid) storage
- diesel power generators and solar arrays
- bunding for blast wave deflection
- office, laboratory and research related facilities
- visitor viewing facilities
- road transport access.

The project is proposed to be constructed on private land that is predominantly covered with native vegetation and is subject to a Heritage Agreement under the *Native Vegetation Act 1991*. The Heritage Agreement was placed on the land in 1988. Attachment 1 provides a map showing the general location of the proposed development and the extent of the Heritage Agreement.

The development aligns with both State and Federal Government priority which seeks to develop a space industry in South Australia. The Australia Space Agency, which is a federal Government Agency, was opened in Adelaide in February of this year. The state Department for Trade, Tourism and

Investment (DTTI) also actively supports the development of the space industry in the State, including through the formation of the South Australian Space Industry Centre (Attachment 2).

DISCUSSION

Environmental values

The Heritage Agreement area is 2,149 hectares is size and is located in the Talia IBRA Subregion and the Mungerowie IBRA Association, which contains 56% and 87% vegetation remnancy respectively.

The HA area is highly exposed to the Great Australian Bight, with shallow and rocky soils or dune systems. As a result, the vegetation is generally characterised by low or very low coastal shrublands which transitions to mallee vegetation further inland with deeper soils and less exposed sites.

The quality of the vegetation on the site varies with some highly disturbed sites with poor condition vegetation in some locations, however a majority of the vegetation is in good condition, with species and structural diversity comparable with what would be expected in the respective vegetation communities.







Example photos of typical vegetation located in the areas of the proposed development.

It is not expected that the site will contain any vegetation communities of conservation significance. However, the site is considered highly likely to provide habitat for a range of threatened species. In particular, the site is known to provide habitat for the following species of conservation significance;

The HA may also provide core or general habitat for additional threatened species. Detailed assessment, particularly during spring, will be needed to confirm the presence of these species or suitable habitat.

NVC Considerations

Given this project has been declared a Major Development under the *Development Act 1993*, the subsequent clearance associated with the development will be considered under Native Vegetation Regulation 12, Schedule 1; Clause 27 – Major Developments. Under this regulation, clearance of native vegetation is permitted if the environmental impact statement, public environmental report or development report has been provided to the NVC for comment and the comments have been included (wholly or substantially) in the relevant Assessment Report. The NVC must also approve the achievement of the Significant Environmental Benefit (SEB) for the clearance. Therefore, in relation to Major Developments, the NVC is not responsible for approving the clearance of native vegetation, but does make the determination in relation to the SEB.

However, the Major Development regulation does not apply to land that is subject to a Heritage Agreement. Therefore, should the development receive approval, the clearance would not be able to occur on land to which Heritage Agreement applies. In order to enable the clearance to proceed, the Heritage Agreement would need to be varied in order to remove the land that will be impacted by the development from the agreement. Under Section 23 of the Native Vegetation Act, the Minister for the Environment and Water can, with the agreement of the owner of the land, vary or terminate a Heritage Agreement. However, the Minister cannot vary or terminate a Heritage Agreement without first consulting and obtaining the approval of the Native Vegetation Council.

It is understood that Southern Launch are seeking to commence construction for the Whalers Way Orbital Launch Complex in 2021. To provide further context and explanation to the NVC in relation to the selection of the site, the aspects of the development, the steps taken to avoid and minimise clearance and the proposed approach to providing the SEB, the proponents will provide a presentation to the NVC. The proponents are seeking feedback on the proposal and for a level of certainty in relation to the ability for the development to proceed.

Therefore, the NVC needs to consider if, given the details of the proposed development, it is willing to approve a variation to the Heritage Agreement to accommodate development. Noting, this is an indicative approval only at this stage, as the variation of the Heritage Agreement will require the redrafting of the agreement and the approval of the Minister and the owner of the land as well as the NVC. This also provides the NVC an opportunity to provide feedback in relation to other aspect of the development including the impacts on native vegetation and the proposed SEB approach.

In making a decision on the proposed variation to the HA and providing advice, the NVC should have regard to its functions as described under Section 14 of the Native Vegetation Act. In particular, subsection 2 states that in performing a function, or exercising a power, under this Act, the Council must, amongst other things, not act in a manner that is seriously at variance with the principles of clearance of native vegetation.





14. Southern Launch Facility – variation to Heritage Agreement area Item for Decision

Guest speakers: \$4(1)(a) , Lloyd Damp, \$4(1)(a) Observers: Brianna Fyffe, Andrew Burnell (DPTI).

Roundtable introductions provided. Applicant advised seeking to reconfigure existing areas not covered by Heritage Agreement (HA) within the Whalers Way site. Development is based on growing demand for small satellites. Currently no suitable multi-user small lift launch sites exist – existing developments are designed to launch large rockets. Proposal is to launch the rockets due south so they travel over the south pole as this avoids disruption on shipping and air travel. Direct ascent to orbit with no lateral turns required. Orbit trajectory reviewed.

Site selection for Whalers Way reviewed. Availability of suitable sites in Australia extremely constrained. Extensive research to determine site undertaken, with two factors influencing – those which affect the ability to launch, and those which impact the accessibility and viability. Weighting reviewed with latitude and launch trajectories, along with coastal access, weather, land size, critical National infrastructure. Other site candidates reviewed. Weighted criteria reduced list to Port Lincoln SA, and Albany WA. Whalers Way freehold with other sites National Parks.

Current licence agreement with land owners entitles time to lease the site for the purpose of the Orbital Launch Complex. Site is 2.640ha. Site currently has large areas of intact vegetation, however some degradation from visitor use. Project proposed for 2 launch sites over approx. 35ha. Anticipated 36 launches per annum, small rockets only. Launch hazard radius based on international Ammunition Technical Guidelines, assessment of blast waves etc. Proposed clearance envelopes reviewed with buffer of 10 metres minimum. Areas of good quality vegetation avoided.

Ecological review, desktop assessment, baseline ecological survey, targeted fauna bird survey, and targeted flora survey conducted. Impact assessment and considerations reviewed. Niche species and habitat with main risk of threatened species is in highly specialised niches such as cliff edges or hollows that maintain moisture. No flora species of conservation significance recorded in the baseline ecology survey or the targeted flora spring survey. West Coast Mint Bush listed as Vulnerable are likely to occur in the Project Area. Fauna results include rare and vulnerable species: White Bellied Sea Eagle, Diamond Firetail, Western Whipbird, and Rock Parrot.

SEB resulting from ecological review impact assessment includes 35.34ha of clearance. Discussion around mitigation - design is around minimising site impact ie. No storm water, animal proof fence, noise reduction methods, anything from the site is removed by road. Constructing water deluge system which sprays out water droplets for noise reduction. Native Title Determination with Nauo indicates support. Existing HA agreement is from early 1980's.

Discussion around HA and whether development could fit into exclusion areas. Not possible due to blast zones. A lot of effort has gone into higher impact on highly degraded areas only. Size of HA not to be altered, boundaries moved only. Remaining HA areas to be retained. Hard copies of Biodiversity Management Strategy and Bedrock Study to be provided to NVC (in confidence). Independent monitoring and oversight assured.


Further discussion around impacts to flora and fauna, number of sites, and frequency of launches. Advised launches anticipated to occur early 2021 with proponent seeking inprinciple support for variance to HA and enter into a new HA (with added conditions ie. Management Plans, Monitoring etc.), CEMP etc.

I am concerned that the stage 1 sections of the 35 predicted launches per year fall into the sea and will not be recovered.

If the Council agree to this, the conditions regarding:

- the size of the new exclusions matching the existing exclusions
- their commitments to rehabilitation of the degraded sites
- ongoing monitoring (and Departmental oversight of the monitoring) and
- no further clearance for whatever reason, including for fire safety need to be set in stone.

Whalers Way Orbital Launch Complex

Dear Lloyd

The Native Vegetation Council (NVC) would like to thank you, as well as \$4(1)(a) for attending the NVC meeting on 4 November 2020 to discuss Southern Launch's proposed Whalers Way Orbital Launch Complex. The NVC appreciated the opportunity to discuss the project and to consider the actions that Southern Launch are proposing to undertake to minimise and mitigate the impacts of this project on native vegetation and native fauna.

The Whalers Way Orbital Launch Complex is located on land at the southern tip of the Eyre Peninsula, at Whalers Way, Sleaford. It is understood that Whalers Way has been identified as the preferred location of the launch complex through a review of potential locations across Australia.

Southern Launch is seeking to establish infrastructure that will support the launch of domestic and international launch vehicles providing Polar and Sun Synchronous Orbit satellite insertion.

The project has been declared as a major Development under the Subsection (1) of Section 46 of the *Development Act 1993* and is intended to include the follow components;

- assembly facilities (both temporary and permanent)
- secure block houses, blast walls and firing bunkers
- lightning rods and anemometer towers
- propellant (liquid, hybrid and solid) storage
- diesel power generators and solar arrays
- bunding for blast wave deflection
- office, laboratory and research related facilities
- visitor viewing facilities
- road transport access.

The project is proposed to be constructed on private land that is predominantly covered with native vegetation and is subject to a Heritage Agreement under *the Native Vegetation Act 1991*. The Heritage Agreement was placed on the land in 1988.

Given this project has been declared a Major Development under the *Development Act* 1993, the subsequent clearance associated with the development will be considered under Native Vegetation Regulation 12, Schedule 1; Clause 27 – Major Developments. Under this regulation, clearance of native vegetation is permitted if the environmental impact statement, public environmental report or development report has been provided to the NVC for comment and the comments have been included

Government of South Australia (wholly or substantially) in the relevant Assessment Report. The NVC must also approve the achievement of the Significant Environmental Benefit (SEB) for the clearance. Therefore, in relation to Major Developments, the NVC is not responsible for approving the clearance of native vegetation, but does make the determination in relation to the SEB.

However the Major Development regulation does not apply to land that is subject to a Heritage Agreement. Therefore, should the development receive approval, the clearance would not be able to occur on land to which Heritage Agreement applies. In order to enable the clearance to proceed, the Heritage Agreement would need to be varied in order to remove the land that will be impacted by the development from the agreement. Under Section 23 of the Native Vegetation Act, the Minister for the Environment and Water can, with the agreement of the owner of the land, vary or terminate a Heritage Agreement. However, the Minister cannot vary or terminate a Heritage Agreement without first consulting and obtaining the approval of the NVC.

The NVC would like to acknowledge that the land that is subject to the development is of high ecological value, representing an extensive area of high quality native vegetation and critical habitat for native fauna including a number of both State and Nationally threatened species. The value of the site is further enhanced through the area being formally protected for more than 30 years, for the purpose of preserving these values. Such areas should be avoided from any form of development where ever possible.

In relation to this development, Southern Launch have provided information indicating that there are a unique and relatively inflexible set of requirements that need to be met when determining an appropriate location for a rocket launching facility. The NVC understands that it is these requirements that has led to the selection of the proposed site of the development, and that there are limited alternative viable options available. It is also acknowledged by the NVC, that whilst the subject land has been protected by a Heritage Agreement since 1988, there are some parts that have been degraded through past clearance and recreational related activities. Additionally, the Heritage Agreement itself contains a number of exclusion areas, being areas that are not subject to the agreement, that are scattered through the Heritage Agreement. Therefore, it is likely that a level of development was anticipated to occur within the Heritage Agreement when it was first established, and that such development could potentially still occur.

In the presentation provided by Southern Launch to the NVC on 4 November 2020, Southern Launch proposed that in order to accommodate the development on the site, that Southern Launch, on behalf of the owners of the land, will request to have the Heritage Agreement varied by moving and consolidating the existing exclusion areas into the locations of the proposed development. Southern Launch asserted that this approach would leave the overall size the Heritage Agreement largely unchanged. Southern Launch also committed to using the existing vehicle tracks on site for access and placing elements of the development in the more degraded areas of vegetation where possible. Southern Launch also indicated that degraded areas that remain within the Heritage Agreement will be managed and improved, through ecological restoration activities.

Re: Protection of Heritage Agreement 148 at Whalers Way on the Eyre Peninsula

Dear Ms Jenke,

The Nature Conservation Society of South Australia (NCSSA) is deeply concerned about the protection of Heritage Agreement number 148, on the southern tip of Eyre Peninsula, in an area known as Whalers Way.

According to the minutes of the Native Vegetation Council (NVC) meeting number 230, held on 4 November 2020, the NVC received a presentation from Southern Launch, the company proposing to develop a rocket launching facility at this site (see <u>Attachment A</u> for relevant extract).

The NCSSA undertook a site visit to Whalers Way on 9 April 2021, hosted by Southern Launch, and is deeply concerned that:

The information presented to the NVC was inaccurate and incomplete.

The minutes include the statement that 'Areas of good quality vegetation avoided', whereas the area earmarked as Site A for the larger of the two proposed rocket launch pads in the map at Attachment B is untouched coastal heath and certainly 'good quality vegetation'. There is some visitation impact at Site B and it is adjacent to a disturbed area, however, the majority of that site which is earmarked for the launchpad itself is also 'good quality' vegetation and/or naturally occurring bare ground. Photos of Site A and Site B are included at Attachment C.

The NCSSA therefore asserts that the statement 'A lot of effort has gone into higher impact on highly degraded areas only' from the minutes is inaccurate. The NCSSA acknowledges that there are some areas of degraded vegetation within the Heritage Agreement, particularly in the vicinity of the "workshop area" as marked on the map at <u>Attachment B</u> and reflected in the photo in <u>Attachment C</u>. However, the NCSSA understands that the majority of the proposed clearance for

both the launch pads and most of the associated infrastructure will be in areas of good quality native vegetation.

A glaring omission from the list of species of conservation concern at the site, as recorded in the minutes, is the Southern Emu-Wren (Eyre Peninsula, *Stipiturus malachurus parimeda*), listed as vulnerable under the *Environment Protection and Biodiversity Conservation Act 1999*¹. The NCSSA understands that the next edition of the Action Plan for Australian Birds (in press) will recommend the status of this species be up-listed to 'endangered'. The same is true for the Western Whipbird, also currently listed as vulnerable, which is referenced in the minutes.

The following statement from the minutes does not accord with the NCSSA's understanding of the site: "Niche species and habitat with main risk of threatened species is in highly specialised niches such as cliff edges or hollows that maintain moisture".

The NCSSA therefore strongly recommends the NVC seek independent advice on the condition of the entire Heritage Agreement area, as well as the specific areas which will be cleared if this proposed development is approved. The NCSSA strongly suggests an accredited NVC consultant should provide such advice, including accurately mapping the true extent of disturbance and degradation at the site, particularly around the "workshop area".

In the interim, the NCSSA would be willing to present to the NVC on its understanding of the site and its condition, if that would be helpful to the NVC.

2. A Heritage Agreement is between the Minister for Environment and the landowner.

As far as the NCSSA understands, a Heritage Agreement is between the Minister for the Environment and the landowner. The NCSSA strongly suggests the NVC undertake due diligence to ensure that the landowner wishes to vary the Heritage Agreement in the manner that has been suggested by the company and/or that the company is entitled to seek a variation to the Heritage Agreement on the landowner's behalf.

3. Expansion of the proposal in future, and true extent of clearance/impact of development

The NCSSA notes from the minutes that the NVC was advised of two launch pads over an area of approximately 35 hectares, which presumably indicates the size of the area likely to be impacted.

The NCSSA is concerned that the State Planning Commission's 'Guidelines for the preparation of an Environmental Impact Statement: Whalers Way Orbital Launch Complex' (July 2020) state that up to six launchpads could be developed at the site. The NCSSA therefore seeks clarity as to how the development, if approved, will be prevented from expanding in future, resulting in further damage and degradation to the area.

The NCSSA is also concerned about fire risk at the site, and suggests the NVC should seek clarity as to what further impact to the site will result from the need to address this risk. This is particularly in terms of the likely need to establish additional new tracks and/or widen existing tracks to improve access, as well as the establishment of asset protection and bushfire buffer zones around the new infrastructure, if the development is approved.

As the NVC would be well aware, the making of a Heritage Agreement with a landowner represents a binding, long-term commitment to biodiversity conservation. The NCSSA is deeply concerned that allowing an industrial development within a Heritage Agreement sets a very poor precedent regarding the perceived value of these areas both for biodiversity conservation as well as more generally to the community.

The NCSSA is unclear as to the status of this particular agreement in light of the 'approved recommendation' as minuted, and respectfully asks for clarity as to whether or not the Heritage Agreement has been amended on the property title 'to enable the development to proceed'.

Roundtable introductions provided. Applicant advised seeking to reconfigure existing areas not covered by Heritage Agreement (HA) within the Whalers Way site. Development is based on growing demand for small satellites. Currently no suitable multi-user small lift launch sites exist – existing developments are designed to launch large rockets. Proposal is to launch the rockets due south so they travel over the south pole as this avoids disruption on shipping and air travel. Direct ascent to orbit with no lateral turns required. Orbit trajectory reviewed.

Site selection for Whalers Way reviewed. Availability of suitable sites in Australia extremely constrained. Extensive research to determine site undertaken, with two factors influencing – those which affect the ability to launch, and those which impact the accessibility and viability. Weighting reviewed with latitude and launch trajectories, along with coastal access, weather, land size, critical National infrastructure. Other site candidates reviewed. Weighted criteria reduced list to Port Lincoln SA, and Albany WA. Whalers Way freehold with other sites National Parks.

Current licence agreement with land owners entitles time to lease the site for the purpose of the Orbital Launch Complex. Site is 2.640ha. Site currently has large areas of intact vegetation, however some degradation from visitor use. Project proposed for 2 launch sites over approx. 35ha. Anticipated 36 launches per annum, small rockets only. Launch hazard radius based on international Ammunition Technical Guidelines, assessment of blast waves etc. Proposed

clearance envelopes reviewed with buffer of 10 metres minimum. Areas of good quality vegetation avoided.

Ecological review, desktop assessment, baseline ecological survey, targeted fauna bird survey, and targeted flora survey conducted. Impact assessment and considerations reviewed. Niche species and habitat with main risk of threatened species is in highly specialised niches such as cliff edges or hollows that maintain moisture. No flora species of conservation significance recorded in the baseline ecology survey or the targeted flora spring survey. West Coast Mint Bush listed as Vulnerable are likely to occur in the Project Area. Fauna results include rare and vulnerable species: White Bellied Sea Eagle, Diamond Firetail, Western Whipbird, and Rock Parrot.

SEB resulting from ecological review impact assessment includes 35.34ha of clearance. Discussion around mitigation - design is around minimising site impact ie. No storm water, animal proof fence, noise reduction methods, anything from the site is removed by road. Constructing water deluge system which sprays out water droplets for noise reduction. Native Title Determination with Nauo indicates support. Existing HA agreement is from early 1980's. Discussion around HA and whether development could fit into exclusion areas. Not possible due to blast zones. A lot of effort has gone into higher impact on highly degraded areas only. Size of HA not to be altered, boundaries moved only. Remaining HA areas to be retained. Hard copies of Biodiversity Management Strategy and Bedrock Study to be provided to NVC (in confidence). Independent monitoring and oversight assured.

Further discussion around impacts to flora and fauna, number of sites, and frequency of launches. Advised launches anticipated to occur early 2021 with proponent seeking in-principle support for variance to HA and enter into a new HA (with added conditions ie. Management Plans, Monitoring etc.), CEMP etc.

Re: Heritage Agreement 148 at Whalers Way

Thank you for your letter dated 13 April 2021 to Ms Emily Jenke, regarding your concerns about the protection of Heritage Agreement 148 at Whalers Way on the Eyre Peninsula. Although not present on 2 November 2020, as the Presiding Member of the Native Vegetation Council (NVC), I am pleased to respond to your letter.

I note your concerns with the information presented to the NVC, specifically regarding the description of the vegetation quality onsite and threatened species habitat. Thank you for providing your understanding of the site, informed by your recent site visit, and your offer to present to the NVC.

As you may be aware, the NVC is supported by members of the Native Vegetation Branch (the Branch). In the course of the statutory assessment process, the Branch has been provided with additional technical documentation for consideration. Key members of the Branch and departmental ecology experts have also undertaken a site visit and have an understanding of the vegetation at each of the proposed development sites. In addition to the presentation made by Southern Launch, I am informed that the Council were briefed by the Branch regarding the environmental values of the site and the Heritage Agreement (HA). Please be assured that, although reference to the Southern Emu-Wren (Eyre Peninsula) (Stipiturus malachurus parimeda) was omitted from the presentation, the NVC are aware that the site provides habitat for threatened species, including the Southern Emu-Wren.

Regarding your suggestion to obtain independent advice on the condition of the vegetation within the HA, the State Planning Commission's Guidelines (SPC Guidelines) require a Data Report to be prepared by an NVC Accredited Consultant. Furthermore, a Fauna and Flora Assessment and Management Plan is required to be submitted as part of the Environmental Impact Statement (EIS). The combination of reports is intended to ground truth the existing conditions and identify the potential impacts on State and Nationally threatened species and their habitats.

The current documentation proposes two launch pads and associated infrastructure, with an extent of approximately 35 hectares. Assuming the forthcoming EIS includes two launch pads, the Branch will contribute to the technical assessment of this extent. The process to develop any additional launch pads will require further information, an additional assessment and an amendment to the EIS. Regarding your concerns about the impact of managing the fire risk onsite, the SPC Guidelines require the EIS to address this matter and quantify the impact on native vegetation.

Under the *Native Vegetation Act 1991*, variations to Heritage Agreements require the written consent of three parties; being the current landowner, the NVC and the Minister for Environment and Water. Although the current landowner, Theakstone Property Pty Ltd, has entered into a lease with Southern Launch over a portion of Allotment 101, the landowner retains the obligations of the HA, including the responsibility of executing any variation.
