Delegate authority to the Director Planning, Heritage, Coast Protection and Dog & Cat Management (DEW Position P47318), Manager Coast Protection (DEW Position M19812) and the Principal Coast and River Planner (DEW Position M19731) to defend the Board's established position and provide instructions to the Crown Solicitor's Office acting for the Board in the conduct of the appeal.
