Legislation

National Parks and Wildlife Act 1972 (Section 59) National Parks and Wildlife (Wildlife) Regulations 2019

Overview

The Department for Environment and Water (DEW) is responsible for regulating the keeping and selling of wildlife (i.e. native animals) in accordance with the *National Parks and Wildlife Act 1972* ('the Act') and all Regulations and Proclamations made under the Act. A permit is required to export protected animals, or the carcasses or eggs of protected animals, out of South Australia.

Under the Act it is an offence to export a protected animal without a permit. Maximum penalty \$2000.

Permit description

The permit entitles the holder to export out of South Australia, a protected animal, or the carcass or egg of a protected animal.

Policy statement

Regulating the movement of protected animals enables the Department to ensure that protected animals have been legally acquired, and to assist with safeguarding against biosecurity risks (e.g. disease prevention).

Animal welfare

The welfare of all native animals is important to DEW and the treatment of native animals must comply with the *Animal Welfare Act 1985* and any applicable code(s) of practice, animal welfare standards, guidelines or procedures where they exist.

Can the permit be transferred?

No. A permit is not transferable.

Will a permit be guaranteed?

Lodging an application does not guarantee approval and the issuing of a permit. You will be contacted if further information is required to complete the assessment.

How long will it take to assess an application?

Please allow sufficient time for your application to be assessed. Assessment and approval of this application may take up to five (5) working days.

Fees

There are no fees applicable to this permit.

Guidelines for applicants

For import of animals (including taxidermy), please refer to section A of the applicant information.

For imports of kangaroo carcasses and skins relating to the kangaroo industry, please refer to section B of the applicant information.

Where the proposed activity involves the movement of protected animals or samples taken pursuant to a scientific research permit, please contact staff at <u>DEWresearchpermits@sa.gov.au</u>, to obtain the necessary approvals.

A. Export of Animals (including Taxidermy)

How do I apply for a permit?

You will need to follow these steps:

- 1. Provide all information requested in this application form.
- 2. Ensure the application declaration is signed and dated.

Do I need to keep records?

Yes, if you are the holder of a section 58 permit you must record any exports in your protected animal's record book and submit an annual fauna stock return 14 days after the expiry of your permit.

Further permits may not be granted unless the completed return is submitted.

How long does a permit last?

This permit expires one month from the date of issue or immediately after the consignment has taken place.

Lodging an application

Lodging an application does not guarantee approval of a permit. You will be contacted if further information is required to complete the assessment.

Please allow sufficient time for your application to be assessed. Assessment and approval of this application may take up to five (5) working days.

B. Export of Kangaroo Carcasses and Skins

For the export of kangaroo carcasses or skins legally acquired through the South Australian Commercial Kangaroo Management Program, the applicant must be the holder of a Class 7 Permit to Sell Protected Animals (Kangaroo Meat Processor) or a Class 8 Permit to Sell Protected Animals (Tannery and Skins).

An export permit holder is permitted to send multiple consignments of kangaroo carcasses or skins and the sum total of all consignments sent must not exceed the quantity per species that is specified in the permit

How do I apply for a permit?

Do I need to keep records?

Yes, if you are the holder of a Class 7 permit under Section 58 of the Act. You must record any exports in your meat processor return within 48 hours of sending them, and submit this information in your return to DEW within 14 days from the end of the calendar month.

Further permits may not be granted unless the completed return is submitted.

How long does a permit last?

An export permit may have a duration of up to 3 months. The permit expires when the permitted number of animals or skins of each species, or the expiry date, is reached, whichever occurs first.

Lodging an application

Lodging an application does not guarantee approval of a permit. You will be contacted if further information is required to complete the assessment.

Please allow sufficient time prior to exports for your application to be assessed. Assessment and approval of this application may take up to five (5) working days.
