MARINE PARKS COUNCIL OF SOUTH AUSTRALIA

Section 24 of the *Marine Parks Act 2007* (the Act) establishes the Marine Parks Council of South Australia (the Council) to provide advice to the Minister for Environment and Conservation on matters associated with the establishment and management of South Australia's marine parks.

MARINE PARKS COUNCIL FUNCTIONS

The Council's functions, as defined in section 29 of the Act, are as follows:

- (a) To provide advice to the Minister on the establishment of marine parks, including:
 - (i) advice on any community nominations for marine parks; and
 - (ii) advice on the areas to be specified as marine parks;
- (b) To provide advice to the Minister in relation to the introduction, variation or revocation of interim protection orders;
- (c) To provide advice to the Minister in relation to a proposal to alter the boundaries of a marine park;
- (d) To provide advice to the Minister in relation to a proposal to establish or alter a zone within a marine park;
- (e) To provide advice to the Minister in relation to the management of marine parks, the formulation and operation of management plans under this Act, and the extent to which the objects of the Act are being achieved through the implementation of management plans under this Act;
- (f) To provide advice to the Minister on ways to promote community participation in the management of marine parks and the conservation of relevant marine environments;
- (g) To carry out such other functions as may be assigned to the Council by or under this Act or by the Minister.

MARINE PARKS COUNCIL MEMBERSHIP

The Council consists of eleven members. Ten members are appointed by the Governor on the nomination of the Minister, and one member (*ex officio*) is the Chief Executive of the Department of Environment and Natural Resources (DENR), or a person nominated by the Chief Executive. Of the ten members appointed by the Governor:

- One must be a person who has knowledge of, or experience in, the field of commercial fishing;
- One must be a person who has knowledge of, or experience in, the field of aquaculture;
- One must be a person who has knowledge of, or experience in, the field of recreational fishing;
- Three must be persons who have knowledge of, or experience in, the field of marine conservation;
- Two must be persons who have qualifications or experience in a field of science that is relevant to the marine environment;
- One must be a person who has extensive involvement in community affairs; and
- One must be a person who has extensive knowledge of indigenous culture, especially in connection with the marine environment.

Mr David Ellis and Mr Douglas Milera were appointed to the Council for a three-year term on 1 July 2010. Mr Milera resigned on 9 October 2010. The inaugural three-year terms of appointment of eight members concluded on 21 May 2011. Nominations were sought in early 2011 to fill vacancies on the Council.

ACTIVITIES OF THE MARINE PARKS COUNCIL

Summary of activities undertaken by the Council

The Council met nine times during the 2010-11 reporting period.

At each meeting the Council received presentations and/or papers relating to the South Australian marine parks program to help the Council to fulfil its functions under the Act. Council used this information to prepare advice for the Minister, and to provide valuable feedback to DENR.

During the reporting period the Council provided advice to the Minister and DENR on matters directly relevant to its functions under sections 29(1)(d), (e) and (f) of the Act, as well as a range of matters associated with the marine parks project, including the following:

- advice from the Scientific Working Group regarding the application of the marine park 'adequacy' Design Principle in relation to sanctuary zoning;
- the community engagement process, including the Marine Park Local Advisory Group (MPLAG) exercise;
- processes and issues associated with the management of displaced recreational and commercial fishing effort which may result from marine parks zoning;
- the review of environment and sustainability targets for the revision of South Australia's Strategic Plan;
- considerations for the preparation of marine park environmental, social and economic impact statements;

- the application of marine park socio-economic Design Principles to marine park zoning;
- assessment and reporting frameworks to assess the effectiveness of operational marine parks;
- draft Indigenous Engagement and Communication Strategies relating to the marine parks management planning process;
- the marine parks zoning matrix;
- the Marine Parks Act and its interaction with other legislation;
- the development of preliminary sanctuary zone scenarios prior to their consideration by Marine Park Local Advisory Groups;
- media representation of the marine parks project;
- the identification and establishment of marine park restricted access zones;
- communications and community engagement prior to the release of draft management plans for public comment;
- advice on how to reconcile divergent views of stakeholders regarding sanctuary zones: and
- · operating procedures of the Council.

Plans and Objectives

The reporting on the achievement of relevant targets under South Australia's Strategic Plan is contained within the DENR Annual Report 2010-11.

MARINE PARKS COUNCIL PERFORMANCE

The Council held a special meeting during the 2010-11 reporting period to review its performance. The Council advised the Minister on its recommendations to improve the overall performance of the Council and therefore the quality of advice provided to the Minister. A range of initiatives has been implemented as a result of this advice, including:

- the Presiding Member will meet with the Minister prior to each Council meeting;
- a representative from PIRSA Fisheries and Aquaculture will attend Council meetings;
- representatives from other government agencies will be invited to attend Council meetings at times relevant to specific agenda items;
- the level of information sharing between relevant other groups, such as the Scientific Working Group and national committees, will be increased to improve members' awareness of the overall strategy objectives and objects of the Act;
- the terms of appointment of new Council members will be staggered to assist with succession planning; and
- improved governance support to Council to ensure timely provision of meeting papers.

During the reporting period, the Council also developed and endorsed a Marine Parks Council Risk Management Plan.

RECONCILIATION STATEMENT

The Council acknowledges that the land on which it meets is the traditional lands for the Kaurna people and that it respects their spiritual relationship with their country. The Council also acknowledges the Kaurna people as the custodians of the Adelaide region and that their cultural and heritage beliefs are still as important to the living Kaurna people today.

In fulfilling its functions, the Council is aware of the cultural heritage of traditional owners and strives to achieve mutually satisfying outcomes wherever these matters are concerned.

HUMAN RESOURCE MATTERS

An appointed member of the Marine Parks Council is entitled to remuneration, allowances and expenses as determined by the Minister. Remuneration was paid at the rate of \$221.12 for the Chair and \$176.90 for members per four-hour session.

Appointed members during the reporting period were: Anthony Cheshire, Peri Coleman, David Ellis, Michelle Grady, Peter Owen, Christian Pyke, Douglas Milera, Susan Stovell, Hazel Vandeleur and Trevor Watts.

Staffing

Executive and administrative support is provided by DENR. The Executive Officer for the Council during the reporting period was Ms Julie Rohde and administrative support was provided by Mr Micah Mango.

Disability Action Plan

The Council uses the facilities and services of staff of DENR. The members of the Council are aware of and abide by their obligations under the *Commonwealth Disability Discrimination Act 1992* and the *State Equal Opportunity Act 1984*.
