## The Native Vegetation Council is seeking consultants to become accredited to carry out assessments for:

- Native vegetation clearance applications under the Native Vegetation Act 1991
- Applications or management plans under the Native Vegetation Regulations 2017, including significant environmental benefit (SEB) offset areas
- Other general consultancy work

#### To be eligible for accreditation, you must meet the following criteria:

- Tertiary qualifications in Botany (or related)
- 10 years' experience in a related area
- Have demonstrated knowledge in plant identification
- Have high level report writing skills
- Commit to the full accreditation training requirements, annual reporting to the Native Vegetation Council, and continuing professional development

#### **Conditions of accreditation**

- 1. Accreditation requires satisfactorily completing the Native Vegetation Council Assessment and Application Training, in addition to the relevant field training in the Scattered Tree Assessment, Bushland Assessment and/or Rangelands Assessment methods;
- 2. Accreditation will be held by you as an individual, not your organization;
- 3. Accreditation will be reviewed on an annual basis by the Native Vegetation Council; and
- 4. Accreditation may be withdrawn at any time at the discretion of the Native Vegetation Council.
