DESIGNATION OF STATE HERITAGE AREA


Where the Minister considers that an area of land is part of the physical, social or cultural heritage of the State and that it has significant aesthetic, historical or cultural interest, then the Minister may designate that area of land as a State Heritage Area.

Pursuant to the provisions of Section 13 of the South Australian Heritage Act, 1978-1980, I Don Hopgood, Minister for Environment and Planning and Minister for the time being administering the said Act hereby designate the area defined and shown in The Schedule as a State Heritage Area.

THE SCHEDULE

Description of Land

All that land being portion of section 24, hundred of Mudla Wirra, bounded as follows: Commencing at a point on the north-western corner of allotment 139 of section 24 laid out as Gawler in the plan deposited in the General Registry Office No. 138 of 1863; thence proceeding easterly along the northern boundaries of allotments 139, 138, 137, 136, 135 and 134 to the north-eastern corner of allotment 134; thence southerly and easterly along the boundary of the land contained in Certificate of Title Register Book Volume 2159 Folio 120 to the south-eastern corner of the said land; thence northerly along the western boundary of allotment 131 to the north-western corner of allotment 131; thence westerly along the southern boundary of the land comprised in Certificate of Title Register Book Volume 2821 Folio 51; thence northerly along the western boundaries of the land comprised in the Certificates of Title Register Book Volume 2821 Folio 51 and 52 to the south-western corner of allotment 148; thence north-westerly to the south-eastern corner of allotment 147; thence northerly along the eastern boundary of allotment 147 to the north-eastern corner of allotment 147; thence easterly along the northern boundary of allotment 158 to the north-western corner of allotment 157; thence southerly along the western boundary of allotment 157 to the south-western corner of allotment 157; thence easterly along the northern boundary of allotment 149 to the north-eastern corner of allotment 149; thence southerly along the eastern boundary of allotment 149 to the south-eastern corner of allotment 149; thence easterly along the southern boundaries of allotments 150, 151 and 152 to the north-western corner of allotment 124; thence north-easterly along the north-eastern boundaries of allotments 124, 123 and 122 to the northern comer of allotment 122; thence south-easterly along the north-eastern boundary of allotment 122; thence continuing south-easterly across King Street to the western boundary of allotment 121; thence southerly and south-easterly along the western boundaries of allotments 121 of G.R.O Plan 138 of 1863 and 218, 217, 216 and 215 of Filed Plan 7306 to a point meeting the production of the north-eastern boundary of the former Presbyterian Church on Pt. Allotment 95; thence south-westerly along the north-eastern boundary of the former Presbyterian Church on Pt. Allotment 95 to the south-eastern corner of the Church's land; thence westerly and north-westerly along the northern boundaries of allotments 97 and 98; thence continuing westerly to the northern corner of allotment 99; thence southerly along the western boundary of Reid Street to the south-eastern corner of allotment 99; thence south-westerly along the south-eastern boundaries of allotments 99, 100, 101, 102; thence westerly along the southern boundary of allotment 103 to the south-western corner of allotment 103; thence continuing south-westerly across Dundas Street to the north-eastern corner of allotment 76; thence southerly along the eastern boundary of allotment 76 to the south-eastern corner of allotment 76; thence south-westerly and westerly along the southern boundaries of allotments 76, 75, 74, 58, 59, 60, 61 and 62 to the south-western corner of allotment 62; thence north-easterly along the north-western boundary of allotment 62 to the north-western corner of allotment 62; thence continuing north-westerly across Porter Street to the south-eastern comer of allotment 67; thence westerly along the southern boundaries of allotments 67 and 66 to the south-western corner of allotment 66; thence northerly along the western boundary of allotment 66, the production to the said boundary and the western boundary of allotment 139 to the point of commencement.
