SOUTH AUSTRALIAN HERITAGE ACT, 1978-1980

Designation of State Heritage Area

WHERE the Minister considers that an area of land is part of the physical, social or cultural heritage of the State and that it has significant aesthetic, historical or cultural interest, then the Minister may designate that area of land as a State Heritage Area.

Pursuant to the provisions of Section 13 of the South Australian Heritage Act, 1978-1980, I, Don Hopgood, Minister for Environment and Planning and Minister for the time being administering the said Act hereby designate the area defined and shown in The Schedule as a State Heritage Area.


THE SCHEDULE

Description of Land

Comprising that portion of the Hundred of Wallaroo, County of Daly, bounded as follows:

Commencing at the westernmost corner of section 2905; thence along the north-western boundaries of the said section, the western portion of section 2236 and section 1701 northeasterly; across road by a straight line from the northern corner. of the said section 1701 north-easterly to the western corner of section 2888; along the north-western boundaries of the said section 2888 and sections 2889, 2891, 1778 and 2050 northeasterly to the north-western corner of section 2606; along the western boundary of the said section 2606 southerly; along the south-eastern boundaries of the aforesaid section and sections 2605, 2604, 2602, 2601 and 2600 and their production northcasterly to a south-western boundary of section 2333; along the latter boundary and the south-western boundaries of section 2048 and 2049 and their production south-easterly to a northwestern boundary of section 2632; along the latter boundary, the north-western, western and south-western boundaries of section 2866, the south-western boundaries of sections 2057, 2632 and 2634 and the south-eastern boundaries of the said section 2634 and sections 2635, 2636 and 1967 south-westerly, southerly, south-easterly and north-easterly to their intersection with the production north-westerly of the south-western boundary of section 2344, along the latter production and boundary and the southern boundary of the said section 2344 southeasterly and easterly; across road by a straight line from the southernmost corner of the aforesaid section south-easterly to the northern corner of section 2029; along the north-eastern and south-eastern boundaries of the said section 2029 southeasterly and south-westerly; along the north-eastern boundaries of sections 2630 and 1909 south-easterly; along south-eastern boundaries of the said section 1909 south-westerly to the eastern corner of section 2698; across road by a straight line southeasterly to the northernmost corner of section 2701; along

north-western, north-eastern, north-western and western boundaries of the said section 2701 south-westerly, north-westerly, south-westerly and southerly to a south-western corner of the aforesaid section 2701; across road by a straight line southwesterly to the eastern corner of section 2715; along the southeastern boundaries of the said section south-westerly; across road by a straight line westerly to a southern corner of section 2687; along south-western and south-eastern boundaries of the said section north-westerly, south-westerly and north-westerly; along portion of the south-eastern boundary of section 1903 south-westerly to its intersection with the production southeasterly of a south-western boundary of the said section 1903. (the north-eastern boundary of section 2686); along the latter production and boundary north-westerly; along the north-western boundaries of sections 2686 and 2906 south-westerly; across road by a straight line from the western corner of the said section 2906 north-westerly to the southernmost corner of section 2751; along the southern boundary of the said section 2751 and the south-western boundaries of the aforesaid section and sections 2130 and 2750 north-westerly; along a straight line from the western corner of the said section 2750 westerly to the eastern corner of section 1972; along the south-eastern, southwestern, and north-western boundaries of the said section 1972 and north-western boundaries of section 2746 and their production south-westerly, north-westerly, south-westerly, northwesterly, north-easterly, north-westerly and north-easterly to a north-eastern boundary of section 2744; along the latter boundary and the north-eastern boundaries of Crown Land and section 2736 north-westerly; across road by a straight line from the northern corner of the said section 2736 north-westerly to the eastern corner of section 2202; along the south-eastern and south-western boundaries of the said section 2202, the southwestern boundaries of sections 2045 and 2168, the north-western boundaries of the said section 2168 and section 2244, the northeastern boundary of the said section 2244, the north-western boundaries of sections 2863 and 1852 and the north-eastern boundary of the said section 1852 south-westerly, north-westerly, north-easterly, south-easterly, north-easterly and south-easterly; along the eastern boundary of section 2788 northerly, across road by a straight line from a north-eastern corner of the said section northerly to the eastern corner of section 2274; along the south-eastern boundaries of the aforesaid section 2788 northcasterly; across road by a straight line from the eastern corner of the said section 2788 north-easterly to the western corner of section 1814; along the north-western boundary of the said section 1814 and portion of the north-western boundaries of the section 1777 north-easterly to the southern corner of section 2865; thence along the south-western boundary of the said section 2865, south-western and south-eastern boundaries of section 1820 and the south-western boundaries of section 2905 north-westerly, south-westerly and north-westerly to the point of commencement.
