# PLANS AND OBJECTIVES

Natural resources management initiatives undertaken by the Natural Resources Management (NRM) Council are consistent with the strategic directions set out in South Australia's Strategic Plan – *Creating Opportunity*, and with the State NRM Plan.

#### THE STATE NRM PLAN

A key function of the NRM Council is to 'prepare, and to keep under review, the State NRM Plan, and to keep under review the extent to which regional NRM plans, policies and practices adopted or applied by NRM authorities are consistent with the State NRM Plan' (Section 17(1)(c)).

The State NRM Plan identifies a 50-year vision for natural resources management in South Australia. The State NRM Plan contains four goals:

- 1. Landscape scale management that maintains healthy natural systems and is adaptive to climate change.
- 2. Prosperous communities and industries using and managing natural resources within ecologically sustainable limits.
- 3. Communities, governments and industries with the capability, commitment and connections to manage natural resources in an integrated way.
- 4. Integrated management of biological threats to minimise risk to natural systems, communities and industry.

#### LINKS BETWEEN THE STATE NRM PLAN AND THE SA STRATEGIC PLAN

In developing the State NRM Plan the NRM Council has taken direction from the South Australian Strategic Plan.

The State NRM Plan will contribute to delivering all aspects of South Australia's Strategic Plan. In some cases, contributions to the objectives of the South Australia's Strategic Plan are indirect – for example, strategies under each of the four goals in the State NRM Plan provide for 'expanding opportunities' through education, training and Aboriginal employment. In other cases, the links are strong and explicit and these are shown in the table below, with ticks  $\checkmark$  indicating the strength of these links.

# **OPERATIONS AND INITIATIVES**

## **NRM Council priorities**

NRM Council conducted a strategic planning day on 5 December 2008, which resulted in the identification of strategic priorities for the 2009 calendar year. Further to our statutory responsibilities and ongoing priorities of volunteer and aboriginal engagement in natural resources management, NRM Council identified five priority areas that will be focused on for providing strategic advice in 2009. These are:

- 1. Sustainable Landscapes: Ensuring sustainability and productivity of landscapes
- 2. The State NRM Plan: Review, simplify, validate and promote
- 3. *Climate Change:* Mitigation of, and adaptation to climate change through promotion/investment in NRM by communities
- 4. *Communication/Engagement:* Enhance NRM Council's performance and effectiveness by strengthening engagement with stakeholders
- 5. *Water Security:* Availability of water (of appropriate quality) for human, production, environmental and cultural uses

### Implementation of the State NRM Plan

The *Implementation of the State NRM Plan project* began in mid-2006 and has been a significant component of NRM Council's achievements which will be completed in October 2009. The project evaluates the operational performance of the State NRM Plan 2006 by reporting on the implementation of the 108 strategies within the Plan and to analyse these strategies for their effectiveness.

The project was divided into three key stages:

- 1. Preparation of an implementation strategy
- 2. Reporting on implementation
- 3. Preparation of a closure report on the implementation and effectiveness of the State NRM Plan to inform preparation of the next State NRM Plan

This project has been a valuable process for the NRM Council and our wider stakeholders analysing the performance of the plan and identifying a range of learning's from the project.

#### **Caring for Country: Aboriginal NRM Forum**

Caring for Country is integral to Aboriginal culture. One rarely speaks about traditional Aboriginal culture without some sort of reference to the land, sea and waters. Today, the land is not as healthy as it once was, with pest animals and plants, the pressure of human population growth, climate change and fragmentation of natural systems all impacting on the land, sea and waters.

In recognition of traditional land management and to explore this further the NRM Council hosted the *Caring for Country: Aboriginal NRM Forum* in Port Augusta on 25 and 26 September 2008, a significant event for natural resources management in South Australia. This forum gave Aboriginal people from across South Australia the opportunity to talk together, hear about successful Aboriginal projects that have helped care for their land and discuss a range of challenges that need addressing to assist Aboriginal communities to care for country.

The NRM Council convened the forum with leadership and guidance from the Aboriginal State-wide Advisory Committee (ASAC), a subcommittee of the Council. The forum was one of the year's highlights, viewing the opportunities of NRM as holistic and part of traditional Aboriginal culture. This can be strongly inherent and the management of natural resources has been transferred through traditional knowledge such as Ancestral stories for many generations.

### Bridging the Gap between Planning and NRM in a Changing Climate

NRM Council recognised the opportunity to partner with the Premier's Climate Change Council (PCCC) to ensure that South Australia's natural resources sector and ecosystems are managed sustainably with optimum resilience and capacity to adapt to climate change, and influence ways to enhance mitigation strategies for the sector.

Members agreed that both Councils could work collaboratively on many climate change issues. The members identified six climate change priority areas of common interest for NRMC and PCCC collaboration. These areas are:

- 1. Assisting the Government in signing Sector Agreements
- 2. Adaptation to climate change
- 3. Education in its broadest sense
- 4. Research and development
- 5. Offsets

A list of criteria to initiate discussion for when PCCC and NRMC could act as a champion or project sponsor for statewide research proposals were also identified, as shown below:

- 1. Alignment with South Australian priorities Important to compliment investment made in the State Strategic Plan, NRM Plan and SA Greenhouse Strategy.
- 2. Cross-cutting issues or integrated approaches for adaptation to climate change issues
- 3. Multiple outcomes Research and Development that meets more than one state and/or regional priority
- Size of impact Projects that make a large contribution to a significant problem and are able to measure the outcomes achieved
- 5. Fostering new adaptation to climate change partnerships Proposals that provoke partnerships, particularly between users and providers, will be of interest to the Councils.
- 6. Investment leverage When the project has the potential to attract other significant financial and in-kind resources

7. Building on other initiatives Where collaboration with another initiative will build capacity and capability

The NRM Council and PCCC initiated 'Bridging the Gap between Planning and Development and NRM in a Changing Climate' project. The aim of this project is to review and evaluate the draft 30-Year Plan for Greater Adelaide prepared by the Department of Planning and Local Government from the perspective of NRM and climate change to ensure that the appropriate input is provided in the Plan to achieve NRM and climate change objectives.

The review and evaluation process was then used as the basis for preparing a submission to the Minister of Department of Planning and Local Government, which was completed and submitted by the deadline of the end of September 2009. At further meetings with the Department of Planning and Local Government agreement was reached on some amendments to the draft 30-Year Plan for Greater Adelaide.

#### **Climate Change Adaptation Framework**

In partnership with the Premier's Climate Change Council (PCCC), the NRM Council commenced the development of an Adaptation Framework for South Australia. It is widely acknowledged that limits on emissions alone will not be enough to avoid all the impacts of climate change.

The Adaptation Framework aims to provide strategic high-level direction for adaptation to climate change in South Australia; it will guide State Government agencies, local government, non-government organisations, regional organisations and the private sector in developing adaptation responses that will increase resilience of South Australia's key sectors and regions.

#### **Review of regional NRM Plans**

Under the NRM Act the NRM Council is required to provide advice to the Minister for Environment and Conservation on the consistency of regional NRM plans and water allocation plans with the State NRM Plan. NRM Council established the NRM Council Assessment Subcommittee (CASc) to evaluate regional NRM plans and to provide recommendations for Council's consideration.

- Reviewing the Committee's current Terms of Reference and developing a Work Plan on the revised Terms of Reference
- Providing advice on strategies to improve Aboriginal engagement in NRM
- Identifying opportunities to integrate Aboriginal NRM priorities in to the review of the State NRM Plan
- Providing advice to NRM Council on the review of the Aboriginal Lands Trust Act
- Encouraging employment opportunities for Aboriginal people within the NRM process

## Volunteers in Natural Resources Management

The NRM Council continues to support the NRM Volunteer Committee that it established in November 2006. The NRM Volunteer Committee met six times during 2008-09 to continue to advocate and give advice to NRM Council on statewide consistency in support for volunteers in natural resources management.

In partnership with NRM Boards, the committee developed the South Australian NRM Volunteer Recognition Framework. This was a key outcome from the committee's review of the 2007 Premier's NRM Awards, a NRM Council initiative which is held bi-annually in conjunction with the SA Landcare Awards.

The Committee strengthened stakeholder relationships, presenting to the Volunteer Partnerships Action Committee and having involvement with the National Landcare Awards in Canberra.

Committee members have been appointed for their specific knowledge, experience and skills in volunteer management including their ability to consider volunteering from a strategic, statewide perspective. ## Advice to the Minister on the administration and operation of the Act

NRM Council recommended that the Minister consider regulatory amendments to the NRM Act so that plantation forestry's impact on water quantity can be more appropriately managed.

NRM Council advised on the need for water policy consistency and early consultation with NRM Boards about issues that impact on their operations.

## Education and capacity building

NRM Council maintains a website through the NRM gateway which also gives the public access to the regional NRM Boards websites and NRM agencies.

NRM Council produced *NRM Directions SA* a bi-monthly newsletter that reports on South Australia's progress towards integrated natural resources management.

NRM Council held a state-wide forum Caring for County: Aboriginal NRM Forum.

#### Council operating structures and processes

Council have strengthened their approach to delivering on their business plan priorities through closer alignment with agency Chief Executives NRM Group and by endorsing a new role for Inter-Agency Directors members to "champion" each of the priority issues. Council also agreed to place relevant strategic regional NRM Board issues on its strategic agenda.

At the end of each calendar year the NRM Council holds a Strategic Planning Day to determine the strategic items to be discussed the following year. The strategic items are entered into a document "key strategic discussion themes and underpinning activities" (the forward agenda). The forward agenda is updated on a regular basis as new issues arise or timeframes change.

# **ROLE, LEGISLATION AND STRUCTURE**

The NRM Council was established on 9 December 2004 under the auspices of the *Natural Resources Management Act 2004*. This report for the 2008-09 financial year fulfils the requirements of Section 38 of the NRM Act.

#### **OBJECT OF THE NATURAL RESOURCES MANAGEMENT ACT**

The objects of the Act include assisting in the achievement of ecologically sustainable development in the State by establishing an integrated scheme to promote the use and management of natural resources in a manner that—

- (a) recognises and protects the intrinsic values of natural resources; and
- (b) seeks to protect biological diversity and, insofar as is reasonably practicable, to support and encourage the restoration or rehabilitation of ecological systems and processes that have been lost or degraded; and
- (c) provides for the protection and management of catchments and the sustainable use of land and water resources and, insofar as is reasonably practicable, seeks to enhance and restore or rehabilitate land and water resources that have been degraded; and
- (d) seeks to support sustainable primary and other economic production systems with particular reference to the value of agriculture and mining activities to the economy of the State; and
- (e) provides for the prevention or control of impacts caused by pest species of animals and plants that may have an adverse effect on the environment, primary production or the community; and
- (f) promotes educational initiatives and provides support mechanisms to increase the capacity of people to be involved in the management of natural resources.

### ADMINISTRATION OF THE ACT

The Minister for Environment and Conservation is responsible for the administration of the *Natural Resources Management Act 2004*. Pursuant to section 6 of the *Administrative Arrangements Act 1994*, certain functions and powers of the Minister for Environment and Conservation in relation to the South Australian Murray-Darling Basin Natural Resources Management Board have been conferred on the Minister for the River Murray.

#### FUNCTIONS OF THE NATURAL RESOURCES MANAGEMENT COUNCIL

Section 17 of the NRM Act 2004 sets out the functions of the NRM Council:

- (a) to provide advice to the Minister on the administration and operation of this Act; and
- (b) to audit, monitor and evaluate the state and condition of natural resources across the State, and to evaluate and report on—
  - (i) the performance of the NRM authorities established under this Act; and
  - (ii) the integration of natural resources management practices on account of this Act; and
- (c) to prepare, and to keep under review, the State NRM Plan, and to keep under review the extent to which—
  - (i) regional NRM plans; and
  - (ii) policies and practices adopted or applied by NRM authorities,

are consistent with the State NRM Plan; and

- (d) to monitor and evaluate the effectiveness of—
  - (i) this Act; and
  - (ii) the State NRM Plan; and
  - (iii) other natural resources management policies initiated by the Government,

and to provide reports to the Minister, and to other relevant persons and bodies, in relation to these matters; and

- (e) as far as reasonably practicable and appropriate—
  - (i) to promote the implementation of integrated natural resources management practices and principles under other Acts; and
  - (ii) to contribute to the adoption of sound natural resources management policies under the Planning Strategy under the *Development Act 1993*; and
  - (iii) to ensure that natural resources management issues are considered when reports on the state of the environment are being prepared at State level; and
- (f) to assist in the coordination of natural resources management initiatives across 2 or more regions and to resolve any issues that may arise between regional NRM Boards; and
- (g) to convene forums on a State-wide basis to discuss natural resources management issues, and to promote public awareness of sound natural resources management practices; and
- (h) at the request of the Minister, or on its own initiative, to advise the Minister on any matter relevant to the condition of natural resources within the State, or on the management of those resources, to conduct any inquiry or audit, or to provide any other advice or report that may be appropriate in the circumstances; and
- (i) such other functions assigned to the council by the Minister or by or under this or any other Act.
- (2) If the Minister assigns a function to the NRM Council under subsection (1)(i) (other than a function that is not, in the opinion of the NRM Council, a significant extension to its current functions), the NRM Council must cause a statement of the fact of the assignment to be published in its next annual report.
- (3) In performing its functions, the NRM Council should seek to work collaboratively with—
  - (a) other State agencies, agencies of the Commonwealth, and agencies of the other States and Territories, that have functions that are relevant to those of the council; and
  - (b) local government; and
  - (c) relevant industry, environment and community groups and organisations.

#### MEMBERSHIP

Section 13 of the NRM Act provides for the appointment of the NRM Council.

Each of the appointed members of the Council is a person who, in the opinion of the Minister, meets the standards stipulated by Section 13 of the NRM Act for the appointment of members. Members appointed are:

Our common goal is the achievement of ecologically sustainable development in South Australia through an integrated approach to the use and management of the State's natural resources.

#### **REQUIREMENTS FOR ANNUAL REPORT**

Section 20 of the NRM Act requires that the NRM Council must on or before 30 November in each year, provide to the Minister a report on its activities for the financial year ending on the preceding 30 June (and need not provide a report under section 6A of the *Public Sector Management Act 1995*).

The report must be accompanied by annual reports of regional NRM Boards and NRM groups and include any other report or information provided to the NRM Council for inclusion in its annual report.

The Minister must cause a copy of this report to be tabled in both Houses of Parliament within 12 sitting days after receiving the report.

In addition, the Chief Executive of DWLBC must ensure that a copy of this report is published on the Department's website within 5 business days after being laid before both Houses of Parliament.

However, if it is not possible for this report to be tabled by 31 December, the Minister must-

- (a) ensure that a copy of the report is furnished to the Natural Resources Committee of the Parliament by that date; and
- (b) until the report is tabled in both Houses of Parliament, furnish to any Member of Parliament, on request, a copy of the report.

"The NRM Council would like to acknowledge the land on which it meets is the traditional lands for the Kaurna people and that it respects their spiritual relationship with their country. The NRM Council also acknowledges the Kaurna people as the custodians of the greater Adelaide region and that their cultural and heritage beliefs are still as important to the living Kaurna people today."

In fulfilling its functions, the NRM Council is cognisant of the cultural and natural heritage of traditional owners and strives to achieve positive outcomes wherever these matters are concerned.

For meetings held in other parts of South Australia the following recognition is given:

"We acknowledge and respect the traditional custodians whose ancestral lands we are meeting upon here today. We acknowledge the deep feelings of attachment and relationship of Aboriginal peoples to Country. We also pay respects to the cultural authority of Aboriginal people visiting / attending from other areas of South Australia / Australia present here."

If appropriate a traditional owner is invited to provide a welcome to country as occurred at the NRM Council state-wide forum *Caring for Country: Aboriginal NRM Forum*.

#### FREEDOM OF INFORMATION

As a DWLBC controlled entity, the NRM Council participates and abides by the arrangements outlined in the DWLBC Freedom of Information regime. Reporting on this matter is contained in the DWLBC 2008-09 Annual Report.

# **REQUIREMENTS FOR ANNUAL REPORT**

Section 38 of the Natural Resources Management Act requires that the Minister must cause a report to be prepared annually setting out the following information:

- (1) A regional NRM Board must, on or before 31 October in every year, provide to the NRM Council a report on its activities for the financial year ending on the preceding 30 June (and need not provide a report under section 6A of the *Public Sector Management Act 1995*).
- (2) The report must—
  - (a) include an assessment of the extent to which the regional NRM Board has succeeded in implementing its regional NRM plan; and
  - (b) include the audited accounts and financial statements of the regional NRM Board; and
  - (c) be accompanied by the annual reports of the NRM groups within its region; and
  - (d) include other information required by or under this Act or the regulations.

Section 56 – Accounts and Audit of the Natural Resources Management Act requires that:

- (1) An NRM group must cause proper accounts to be kept of its financial affairs and must cause financial statements to be prepared in respect of each financial year.
- (2) The Auditor-General may at any time, and must in respect of each financial year, audit the accounts and financial statements required under subsection (1)

Section 57-Annual Reports of the Natural Resources Management Act requires that:

- (1) An NRM group must, on or before 31 October in every year, provide to the regional NRM Board or Boards that have responsibility for the NRM group a report on its activities for the financial year ending on the preceding 30 June (and need not provide a report under section 6A of the *Public Sector Management Act 1995*).
- (2) The report must-
  - (a) include a copy of the audited accounts and financial statements of the NRM group, and
  - (b) include other information required by or under the regulations.

In regards to Section 57 (2) (b) there are no regulations applying.

# **SPECIFIC REPORTS**

Section 39 of the Natural Resources Management Act states that:

(1) The Minister or the NRM Council may, by written notice to a regional NRM Board, require the Board to provide to the Minister or the NRM Council, within a period stated in the notice or at stated intervals, any report or reports relating to the performance, exercise or discharge of its functions, powers or responsibilities, as the Minister or the NRM Council (as the case may be) thinks fit.

(2) If a requirement is imposed under subsection (1), the regional NRM Board must cause a statement of the fact of the imposition of the requirement to be published in its next annual report.
