Mr Keith Conlon OAM

Keith is the Chair of the Council. Keith is a now retired veteran of radio and TV current affairs in Adelaide, with a well recognised passion for South Australia's heritage and history stories, earning himself the nickname, 'Mr South Australia'.

He maintains his keen interest in our heritage by contributing to History Trust of South Australia programs, leading History Month tours and other events, membership of the SANFL History Committee and even researching and presenting Fringe shows on Adelaide's history.

A keen photographer, he regularly promotes our heritage stories on social media.

Keith's contributions to the community have been recognised with an OAM, University of Adelaide Distinguished Alumni Award, a South Australian Tourism Personal Contribution Award, Honorary Fellowship of the Planning Institute of Australia (SA) and admission to the SA Media Awards Hall of Fame.



Ms Jan Ferguson OAM

Jan is Deputy Chair of the Council. Jan's passion for Heritage stems from her long term association with Beltana, a State Heritage town in the Far North. She has been active in the preservation, promotion and restoration of buildings in the town since 1970.

For over 10 years she has been working on ASIC and Not for Profit registered Boards. Prior to working in the corporate sector, she worked in the public sector and chaired a number of community based organisations.

Her expertise in innovation, research, commercialisation and community development is combined with a

passion for people, teamwork, and social justice especially for rural and remote Australia. She has a flair for building large, effective partnerships across industry, government, academia and the community to understand and solve complex challenges. In 2017 she was awarded an OAM for work done in partnership with Aboriginal and Torres Strait Islander peoples.



Mrs Deborah Lindsay

Deborah has over 15 years’ experience in heritage assessment, policy development and implementation, in State Government and heritage consulting roles, in SA and NSW.

Deborah provides heritage advice on conserving, developing and adapting National, Commonwealth, State and Local heritage listed places, and guidance in relation to historical archaeological matters. Her work includes heritage assessments, heritage impact assessments, conservation management plans, condition assessments, archival

recordings, historical research, due diligence reports and heritage awareness training.

Deborah is a member of the State Planning Commission’s Heritage Subcommittee, and a member of Australia ICOMOS. Deborah currently works as a Senior Heritage Consultant at DASH Architects.



Mr Gavin Leydon

Gavin is an environmental lawyer in private practice with over 30 years’ experience in the areas of development, planning and heritage law. He brings to the Council an understanding of the policy interface between heritage and urban and regional planning.

Gavin regularly appears as an advocate before planning authorities and the Environment, Resources & Development Court. He has been extensively involved in the reform of the State’s planning & development system and the transition to the Planning, Development & Infrastructure Act, including the provision

of advice to State and local government, the Local Government Association & training to the sector. Gavin is also an Honorary Fellow and Executive Member of the SA division of the Planning Institute of Australia and the former Presiding Member of the Local Heritage Advisory Committee.



Ms Katrina McDougall

Kate is a partner in the firm of McDougall & Vines, a long-standing specialist conservation and heritage practice based in Adelaide, with clients in SA, interstate and in Asia.

Her main area of professional interest is all aspects of the history and development of architecture in the community - buildings, styles, architects and town planning - which has informed her extensive work in heritage conservation policy and management. As an historian, Kate is particularly interested the accessibility of information

relating to architectural and social history and its importance in the conservation of the historic built environment. She is also concerned with the preservation and availability to researchers of architectural and associated records, and is chair of the Advisory Group of the Architecture Museum, UniSA.



Professor Peggy Brock AM

Peggy was the first historian to be appointed to the Aboriginal Heritage Branch of the then Department of Environment and Planning in 1982. She researched and registered sites which have historic significance both for Aboriginal communities and non-Aboriginal people in South Australia.

An outstanding example is the Poonindie church north of Port Lincoln (State Heritage listed), and various mission sites, town sites and pastoral stations around the state. Her research also resulted in several publications, including Aboriginal Women, Rites and Sites (ed) and Outback Ghettos: A history of Aboriginal Institutionalisation and Survival.

In 1990 Peggy moved to Perth where she taught at Edith Cowan University

and continued her research into Indigenous and colonial history, returning to Adelaide in 2010. Her most recent book is Colonialism and Its Aftermath: A History of Aboriginal South Australia (co-editor). Prior to her work as a heritage historian, Peggy worked as a planning consultant and social planner. Professor Brock received an AM in 2021 for her ‘significant service to tertiary education, and to Indigenous history’.



Ms Eleanor Walters

Eleanor is a highly experienced planning professional having led a broad range of planning and sustainability projects for local and State Government and private practice.

Recently, Eleanor has been the Transition Manager for Planning, Development and Infrastructure Act 2016 and the Planning and Design Code – including policy input and advocacy, submission preparation, working groups, business readiness co-ordination.

Eleanor is appointed to the Council as the nominee of the Local Government Association and will bring much valued planning skills and knowledge to Council meetings.



Mr Marcus Rolfe

A current Director and former Managing Director of prominent planning consultancy URPS, Marcus has worked in Local/State Government and as a consultant in South Australia, Victoria and New South Wales.

He is widely recognised for his expertise in development assessment/facilitation and planning policy formulation. He is also a Fellow of the Planning Institute of Australia.

Marcus has been a planning advisor to the NSW Heritage Council responsible for assessing nominations for the State Heritage Register. He has also had oversight of several Development Plan Amendments with heritage conservation

Having assessed/facilitated numerous development proposals involving State Heritage Places, Marcus understands the ramifications of State Heritage listing on development projects e.g. Adelaide Film Centre/Glenside Hospital, residential development of Port Adelaide wool stores, dwelling/land division at Paechtown.

Stephen is a heritage architect and currently an associate in the office of Swanbury Penglase Architects. Stephen has significant experience in the management of heritage places, the technical aspects of material conservation, adaptive re-use of heritage places, and a broad knowledge of South Australia’s heritage.

Stephen worked previously as Senior Conservation Architect in Heritage South Australia, providing advice to heritage owners, and assessing development against the impact on the heritage value of State Heritage Places.

Stephen has a PhD in architectural history and is an occasional lecturer and tutor in the history and theory program in the School of Architecture at the University of Adelaide.

Stephen is a member of Australia ICOMOS and the Construction History Society.
