6.2	Heritage Tourism Implementation Plan and Alliance <i>'Growing Our Heritage Future' is a 10 year strategy for growing heritage tourism in South Australia. It provides guidance to the tourism industry, state and local government, Traditional Owners, regional organisations and local communities, and heritage owners, operators, custodians on how to leverage this potential. At this meeting the Council will discuss its role in implementing this Strategy, the delivery of the implementation plan and the future role of the Heritage Tourism Alliance.</i>

	7.2	<p>'Aviemore' 158 Stephen Terrace, Gilberton</p> <p><i>This place has been nominated by a member of the public for consideration. At this meeting the Council will consider an assessment report and determine whether this place meets any of the criteria under section 16 of the Heritage Places Act 1993 to warrant provisional entry on the South Australian Heritage Register.</i></p>

	8.1	<p>Hallett Cove Conservation Park & Sandison Reserve, Hallett Cove</p> <p><i>This is a State Heritage Place that was listed 4 March 1993. At this meeting, the Council will consider whether it warrants designation under section 14 (7) of the Heritage Places Act 1993:</i></p> <p><i>The Council may designate a State Heritage Place as—</i></p> <p><i>(a) a place of geological, palaeontological or speleological significance.</i></p> <p><i>Designation of a place recognises it for its significance and provides for a permit system that will help protect it.</i></p>
