	7.1	Nelly Creek Fossil Flora, Oodnadatta Track, Callana (On Arabana Country) "Australia's Fossil Heritage: A Catalogue of Important Fossil Sites" identified this site at Nelly Creek and therefore it has been assessed for consideration by Council at this meeting. The Council will determine whether it meets any of the criteria for listing under section 16 of the Heritage Places Act 1993.	
	7.2	Poole Creek Fossil Flora Complex, South of Lake Eyre and South and Covrichina Dam. (On Arabana Country) A Fossil Heritage Survey of South Australia has been completed, identifying Poole Creek as one of the State's top priorities for heritage protection. This place has been assessed and Council will consider whether it meets any of the criteria for listing under section 16 of the Heritage Places Act 1993 and whether Council intends to designate it as a place of palaeontological significance.

Council will then determine whether it meets any of the criteria under Section 16 of the Heritage Places Act 1993 to be provisionally entered as a State Heritage Place.
