An assessment has now been completed and at this meeting the Council will consider whether it meets any of the criteria for provisional entry under Section 16 of the Heritage Places Act 1993. At this meeting, the Council will consider whether it meets any of the criteria under Section 16 of the Heritage Places Act 1993 for provisional entry in the South Australian Heritage Register.</i></p>

	8.1	<p>Everard Court, Kaurna Country, 46 Anzac Highway, Everard Park</p> <p><i>This place was provisionally entered as a State Heritage Place by the Council on 8 December 2022 as it met criteria (a), (b) and (e) under s16 of the Heritage Places Act 1993.</i></p> <p><i>At this meeting, the Council will consider the submissions received during the public consultation period and determine whether or not to Confirm Everard Court as a State Heritage Place in the South Australian Heritage Register.</i></p>
	8.2	<p>Semaphore Carousel, Kaurna Country, The Esplanade, Semaphore.</p> <p><i>On 8 December 2022, the Council provisionally entered the Semaphore Carousel in the South Australian Heritage Register as a State Heritage Place as it met criteria (a) and (b) under s16 of the Heritage Places Act 1993.</i></p> <p><i>At this meeting, the Council will consider the one submission received during the public consultation period and determine whether or not to Confirm Semaphore Carousel as a State Heritage Place in the South Australian Heritage Register.</i></p>
