At this meeting the Council will consider any submissions received during the consultation period and consider Confirming this Place in the Register and Designating it as a place of palaeontological significance.</i></p>
	7.2	<p>Poole Creek Fossil Flora Complex, South of Lake Eyre and South and Covrichina Dam, Arabana Country</p> <p><i>On 8 December 2022, the Council provisionally entered Poole Creek Fossil Flora Complex in the South Australian Heritage Register as a State Heritage Place as it meets criteria (b) and (c) under s16 of the Heritage Places Act 1993. At this meeting the Council will consider any submissions received during the consultation period and consider Confirming this Place in the Register and Designating it as a place of palaeontological significance.</i></p>
