Introduction

This information is published in accordance with section 9 of the Freedom of Information Act 1991 (the FOI Act). The FOI Act provides members of the public a legally enforceable right of access (subject to certain restrictions) to documents held by government. The FOI Act allows members of the public to:

- request access to documents held by the Council
- request the amendment of documents that contain personal information about the applicant which is incomplete, incorrect, out-of-date or misleading.

The FOI Act encourages disclosure of information to the public, subject to such restrictions within the FOI Act as are necessary to protect legitimate agency, public and private interests.

Structure of South Australian Heritage Council

The South Australian Heritage Council consists of the following members appointed by the Minister:

(a) not less than 6 and not more than 8 persons who, in the opinion of the Minister, have knowledge of or experience in history, archaeology, architecture, the natural sciences, heritage conservation, public administration, urban and regional planning or property development (or any combination of 2 or more of these fields), or some other relevant field; and (b) 1 person with knowledge of or experience in heritage conservation chosen from a panel of 3 such persons submitted to the Minister by the Local Government Association of South Australia.
