Attachment 1 - Grant Terms & Conditions

Purpose of the Grant

You must use the Grant only for the Approved Item/s specified in the Letter of Offer.

Repayment of Grant

If you fail to comply with this Grant Agreement at any time, Northern and Yorke Landscape Board may:

- withhold future grants from you; and/or
- terminate this Grant Agreement.

Funding and Invoicing

You agree that this Agreement satisfies the requirement for a written agreement specifying the supplies to which the Recipient Created Tax Invoice ("RCTI") relates;

Provision of Information

Northern and Yorke Landscape Board will need to be satisfied you are using the Grant for the Purpose and you are complying with this Grant Agreement.

To enable this, you must provide any information requested by Northern and Yorke Landscape Board or its auditors or financial advisers (including the information listed in the Letter of Offer).

Rules and Legislation

You must comply with all legislation applicable to the Grant and the Purpose and with any constitution or rules which govern your operations.

Acknowledgements

You acknowledge the Grant represents a one-off payment by Northern and Yorke Landscape Board for or towards the Approved Item/s, and you agree any request for subsequent funding will require a new application to Northern and Yorke Landscape Board. Northern and Yorke Landscape Board is not under any obligation to agree to pay any subsequent funding to you.

You acknowledge Northern and Yorke Landscape Board will not be liable to reimburse you for any losses or cost over runs that may result from the operation of this Grant Agreement or the carrying out of the Purpose.

Grant is personal to you

You agree the Grant is personal to you, and you must not assign, transfer, or encumber any of your rights or obligations under this Grant Agreement.

Special Conditions

You must comply with the following Special Conditions:

You warrant that you have not submitted more than one application per person, physical property address/business entity per grant round.

You warrant that you obtained the majority (>50%) of total income from primary production under normal seasonal circumstances.

You warrant that you have not received funding from other Commonwealth and/or State Government programs for the Approved Item/s specified in the Letter of Offer.

You warrant that you hold a current public liability insurance policy with a minimum level of cover no less

than \$1,000,000. To accept the offer, you are required to provide a copy of the policy's Certificate of Currency along with the signed Grant Recipient Details and Acknowledgement and Acceptance of Offer form.

You undertake that the Approved Item(s) will be:

- purchased by you and installed and/or utilised by 30 June 2027.

You undertake that the Project Acquittal form will be:

- completed and submitted to Northern and Yorke Landscape Board by 30 June 2027.

You agree to contact Northern and Yorke Landscape Board immediately if any information provided in your Grant Application changes or is found to be incorrect.

You consent to Northern and Yorke Landscape Board:

- using and releasing information in your Grant Application (excluding personal details) for non-commercial public information purposes and in accordance with relevant legislation; and

In the event of any inconsistency between the documents making up the Grant Agreement, this Grant Agreement will be construed by reference to the following order of priority:

- The Letter of Offer
- Your signed Acceptance of this Offer
- The Grant Terms and Conditions

Privacy

The Recipient must comply with the *Privacy Act 1988* (Cth) ("**Privacy Act**") and the Australian Privacy Principles established under that Act in undertaking its obligations under this Agreement including in relation to all Personal Information received, created or held by it for the purposes of this Agreement.
