Ways in which the functions of the board affect members of the public

The board's purpose is to help achieve ecologically sustainable development in the State by contributing to the establishment of an integrated scheme to promote the use and management of natural resources in a manner that:

- · recognises and protects the intrinsic values of natural resources
- seeks to protect biological diversity and, insofar as is reasonably practicable, to support
 and encourage the restoration or rehabilitation of ecological systems and processes that
 have been lost or degraded
- provides for the protection and management of catchments and the sustainable use of land and water resources and, insofar as is reasonably practicable, seeks to enhance and restore or rehabilitate land and water resources that have been degraded
- seeks to support sustainable primary and other economic production systems with particular reference to the value of agriculture and mining activities to the economy of the State
- provides for the prevention or control of impacts caused by pest species of animals and plants that may have an adverse effect on the environment, primary production or the community
- promotes educational initiatives and provides support resources mechanisms to increase the capacity of people to be involved in the management of natural resources.

In delivering this work, the board focuses on engaging and involving the community, industry and government, to get the best results through seeking out alternative perspectives, building trust with colleagues and partners and collaborating genuinely.

Public participation

Collaboration between government, industry and the community lies at the heart of effective natural resources management. The board's priorities and its ways of working to promote collaboration help build awareness of the importance of healthy natural resources to our wellbeing and economy.

The board involves the public in the formation of its policies through its community liaison sessions, and consultation and discussion papers on specific issues as appropriate.
