

The CFS is requesting BMC members focus on operational delivery of the Bushfire Management Area Plan (BMAP) and remove broader issues of discussion from local meetings. These broader issues are to be raised with the Statewide Bushfire Coordination





6	Presentations		
6.1	Early Environmental Impacts of the Feral Cat Barrier Fence		
	Mr James Newcomer (Indiana James) provided a presentation of his observations of the Cat Barrier Fence and its impacts on the environment. Mr Newcomer has observed:		
	 Intertidal areas bared during construction of the fence are not showing signs of recovery. Considerable amount of rubbish remains along the fence. Cameras are not being maintained (plants growing over lens) Numerous burrows are appearing along the east side of the wire When panicked near the site where the fence turns west, kangaroos are being trapped in the acute angle Damage (bulging) of the fence is appearing. Solar collectors need cleaning A new 4WD track is appearing alongside the fence At the southern end, there is some further destabilisation of the dune from construction Tourist operators are travelling along the fence to the southern end which is 800m from a White Bellied Sea Eagle nest. 		
	The Board thanked Mr Newcomer for his detailed observations and acknowledged the need to work with the community regarding monitoring and maintaining the barrier fence, as we cannot lose sight of the long term outcomes of the fence and the feral cat eradication program.		
	Mr Newcomer tabled his report, together with ten recommendations for consideration by the Board.		
6.2	Autumn Prescribed Burn Season		
	Anthony Sandeman, Senior Regional Fire Management Officer, presented on the plans for DEW's autumn prescribed burns. Four burns have been funded, five operations planned developed and 12 blocks prepared. Which burns are delivered is dependent on weather conditions.		
	Winter burns are also planned for rolled vegetation breaks and edge burns in preparation of the main Spring burn program.		
	Each planned burn takes into consideration protection of life, assets and environment.		
	12 Landscape staff, including the General Manager are members of the DEW CFS Brigade. There is also great collaboration and outcomes occurring between the fire program and projects.		
	Ongoing engagement and education of the community is essential as need to reduce misinformation and change perceptions regarding fire in the landscape.		
6.3	Landcare South Australia The Chair welcomed Sarah Barratt and Deb Laver from Landcare Association of South Australia (LASA) to the meeting and Eleanor Pratt, CEO LASA who joined by Microsoft Teams. Landcare Australia was successful in gaining \$14M to fund fire recovery projects, with eight Kangaroo Island projects funded through the Landcare Led Bushfire Recovery program.		
	An overview was provided of the achievements to date of each project including:		
	 Birdlife Australia and Recovery KI birds – focus on post-fire monitoring and impacts on priority species. Worked closely with schools and volunteers to build awareness and monitoring skills and printing of updated bird booklets. 		



	• SA Museum and Islands within an island – focus on impacts of fire on invertebrate species
	as the biggest threat to invertebrates living in leaf litter is fire.
	• KI Lands for Wildlife and Felixers for fire relief – retrofitting existing Felixer cat grooming traps with artificial intelligence to improve target rate.
	 KI Conservation Landowners Association and Habitat augmentation – detecting bats and pygmy possums post fire, with no sightings of the little pygmy possum to date (possible extinction). This project has seen fantastic collaboration with researchers and community from building artificial nest boxes, trialling locations for installing the nest boxes and recording lessons learnt. Results from this project will help inform future fire recovery response. KI Landscape Board and Fighting Chance – feral cat trapping alert system which will reduce time and labour required to check traps. This is a first for Australia. Nature Conservation Council of SA and Mobilising and Supporting post fire – raising awareness on the importance of plant conservation on private properties & roadsides to increase populations of threatened and endemic flora. PIRSA and Extension of Thermal assisted aerial cull of feral pigs - removing feral pigs from recovering native vegetation to support recovery of KI's biodiversity and reduce impacts of on recovering primary producers.
	LASAs annual Landcare Conference will be replace in 2022 with a series of regional workshops. The workshops aim to bring together regional Landcare groups, celebrate their achievements and challenges and share ideas.
