

NORTHERN AND YORKE LANDSCAPE BOARD: SUSTAINABLE LAND MANAGEMENT SURVEY COMPETITION TERMS AND CONDITIONS

GENERAL

- 1. The organiser of the competition is the Northern and Yorke Landscape Board (NYLB) of 318 Main North Road, Clare South Australia 5453, ABN 83 450 552 896.
- 2. By participating in this competition, entrants agree to abide by competition rules and regulations.

ELIGIBILITY

- 3. The competition entry period commences at 4pm Monday, 23 June 2025 and ends at 5pm Friday, 31 October 2025. NYLB is not responsible for any lost, late or misdirected entries. NYLB is not responsible for the accuracy of entrants' information or personal details.
- 4. NYLB reserves the right to request proof of identity of all winners. Proof considered suitable for verification is at the discretion of NYLB. In the event that a winner cannot provide suitable proof, NYLB in its absolute discretion may disqualify the winner.
- 5. NYLB reserves the right to verify the validity of entries and to disqualify any entrant suspected of tampering with the entry process.
- 6. The competition is open to primary producers in the Northern and Yorke region who complete and submit the Sustainable Land Management Survey between Monday, 23 June 2025 and Friday, 31 October 2025 inclusive.

ENTRIES

- 7. To participate in the competition, entrants must complete a feedback survey.
- 8. Incomplete, indecipherable or illegible entries will be deemed invalid and will be rejected.

PRIZES

- 9. The total value of the prize pool is \$2,100. Winners will receive:
 - Eight (8) random prize draws occurring on a fortnightly basis, commencing on 14th July and concluding on 20th October (valued at \$200 each)

Winners can choose between the following prizes:

- i. soil testing by a local agriculture retailer or agronomist; or
- ii. pest control products from NYLB; or
- iii. plants from Red Centre Enterprises.
- Bonus draw: prize valued at \$500 (random winner to be drawn on Tuesday, 1 July 2025) for those who complete the survey before 30 June 2025.
- 10. Winners will be notified by e-mail.
- 11. Winners' names will only be published with consent from the prize winner.
- 12. Winners will have until 12th December 2025 to claim their prize. Prizes not claimed by this date will be forfeited.

OFFICIAL

- 13. If competition prize winners are under the age of 18 years, the prize will be awarded to the winner's nominated parent or guardian.
- 14. Prizes are not transferable or exchangeable and cannot be taken as cash.
- 15. Any costs associated with the use of prizes are to be covered by the winner.

FINAL CONDITIONS

If any act, omission, event or circumstance occurs which is beyond the reasonable control of NYLB and which prevents NYLB from complying with these terms and conditions, NYLB will not be liable for any failure to perform or delay in performing its obligations and reserves the right (subject to any applicable law) to cancel, terminate, modify or suspend the competition.
