Introduction



On behalf of the Northern and Yorke Landscape Board, I present the 2022-23 Business Plan.

This plan continues the board's commitment to "a resilient and productive landscape that sustains a thriving community, environment and economy", through

a sustained focus on five priority areas; Communities, Biodiversity, Water Management, Sustainable Agriculture and Pest Plant and Animal Control. The programs and projects outlined in this plan deliver against the vision, and complement the priorities and objectives of the Northern and Yorke Landscape Plan 2021-2026 and State Landscape Strategy.

This plan provides that the Board will continue to deliver a combination of on-ground works, policy and strategy development, extension activities and landholder support ensuring that all members of the community have the opportunity to benefit from the work of the Board. The plan provides details of how funding for these initiatives is sourced and distributed in support of the priorities.

The Board has been successful in securing a number of Federal and State Government grants, which will see the delivery of new landscapescale, multi-year projects in the Mid North, Yorke Peninsula and region-wide.

The Australian Government Regional Landcare Projects in the Southern Flinders and Yorke Peninsula are entering their fifth year, with a number of key milestones planned in the early stages of 2022-23. Many of the projects outlined in the plan address multiple priority areas including pest animal and plant control, enhanced or protected biodiversity, soil health, agricultural performance and drought resilience.

The Board recognises the invaluable contributions of its partners, stakeholders and the wider community. The success of the projects outlined in this plan is contingent on the relationships that the Board and its staff maintain with our partners, stakeholders, First Nations peoples, community organisations and not for profit organisations. A strong network of organisations and individuals who work together and have a shared vision for a sustainable future will ensure the activities outlined in this plan are successful.

I invite you to consider this plan and encourage you to support the Board's vision through participation in the programs and projects planned for 2022-23. I look forward to together continuing to strive for a sustainable future for all.

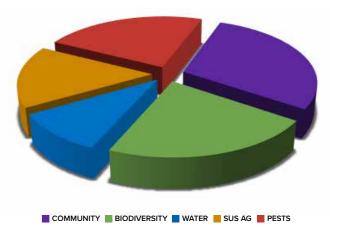

Water Management

Water is a scarce and valuable resource to all who live, work and visit the Northern and Yorke region. Managing the water resource requires considered planning and monitoring, for which the Board holds legislative responsibility for mangement of prescribed water resources areas in the region.

The natural movement of water through the environment is needed to ensure the ongoing health of watercourses and wetlands are maintained. A healthy water course provides environmental and economic outcomes for the region. The Board provides support for water affecting activities through a permitting system, ensuring that water course flows are maintained, and where necessary, repair or reinstatement of the waterflow is enforced.

With 80% of the Northern and Yorke region being utilised for agricultural purposes, and the remaining 20% used for viticulture, market gardening, mining, small farms and residential purposes, soil health is critical to the region's economic sustainability. Pest Plant and Animal Control

Uncontrolled pest plants and animals can have a significant impact on agricultural productivity, biodiversity and human health. The *Landscape South Australia Act 2019* requires action be taken to control pest animals and plants, tasking landowners with the responsibility to manage declared pests on their properties. The Board provides support and assistance to landowners to control existing pest species, and to prevent or reduce the likelihood of new pest threats.

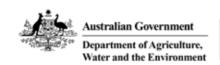

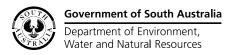

The board and staff

The Northern and Yorke Landscape Board consists of a Presiding Member (Chair) and six community members appointed as Board Members. All board members were appointed by the Minister on the basis of the skills and experience that the member can provide to the Board. The Board and Board Committees meet regularly, holding meetings at towns throughout the region on a monthly or quarterly basis. Visitors are welcome to attend Board meetings which are advertised on the Board website.

The Board delivers on its objectives through the employment of a General Manager, and a team of public sector employees. The Board, through the General Manager, employs 39.09 full-time equivalent staff working to deliver the programs and projects of the Board. Of these positions, 7.4 FTE are funded by the Australian Government through the Regional Landcare Program or through State Landscape Priority funding. The Landscape Board staff work across three districts; Rangelands, Yorke and Mid North, with six offices located throughout the region.

A number of corporate and water science services are provided to the Board through Service Level Agreements with the Department for Environment and Water and the Department of Treasury and Finance, Shared Services SA.

Funding

The Board receives funding through the collection of levies (landscape levy and water levies) and through agreements with the Federal Government or other partners. The table below provides the estimated funding (income) for the 2022-2023 financial year.

Landscape levy

The regional landscape levy, outlined in the *Landscape South Australia Act 2019*, is the primary source of income for the Northern and Yorke Landscape Board. The levy is collected by constituent councils through the council rates process, and forwarded to the Board. Constituent councils have the ability to claim costs associated with collecting the levy on behalf of the Board.

The regional landscape levy provides the funds to enable the Board to undertake its legislatively required functions, including administration of the requirements of the Act and to invest in programs and projects to address the priority areas outlined in the Regional Landscape Plan.

The table below provides the landscape levy to be collected by each constituent council and the collection fees that will be paid by the Board. The landscape levy and collection costs have increased by 2.5% (CPI) from the 2021-2022 amounts.

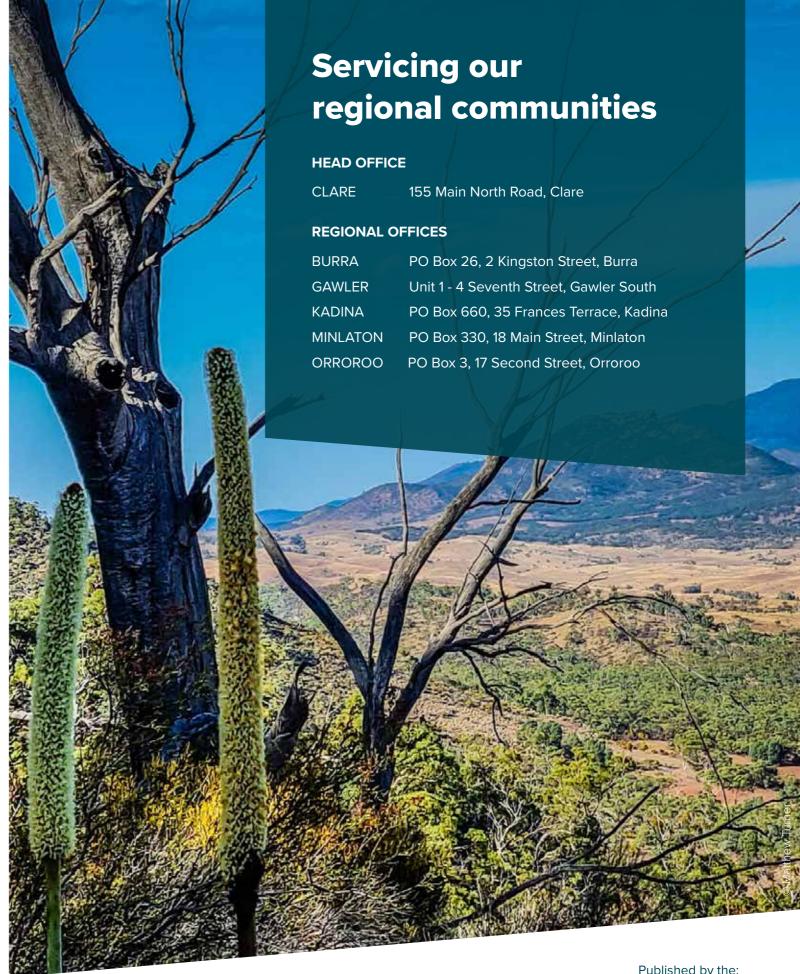

Water levy

The Northern and Yorke Landscape Board region contains five prescribed water resource areas (PWRA). These include the Clare Valley and Barossa Valley and sections of the Marne Saunders, Northern Adelaide Plains and the Western Mount Lofty PWRAs.

Water levies are paid by all water licence holders in the PWRAs. The levy is collected by the Department for Environment and Water and forwarded to the Northern and Yorke Landscape Board. The table below provides the rates at which levies will be charged in the 2022-2023 financial year, and include a Consumer Price Index (CPI) increase of 2.5% on the 2021-2022 levy rates.
