On-Farm Dry Times Grant

Northern and Yorke Landscape Board

The Northern and Yorke Landscape Board is offering Rangeland farmers small grants for infrastructure development projects that help manage the current dry times and increase preparedness for future drought conditions.

What are we offering?

The Board has recognised the impact of significantly low rainfall on primary producers and is offering additional financial assistance to prepare for further dry times.

Grants of up to **\$2,000** per farm are available to improve drought management efficiencies on farm and must be acquitted by 30 June 2024. Limited funds are available, so allocation is on a first-in basis until 12 April 2024, or until funds are depleted.

Who is eligible?

Land managers that own or manage a primary production enterprise that is predominantly:

- located within the District Council of Orroroo Carrieton, District Council of Peterborough, and the Regional Council of Goyder;
- larger than 1500 hectares; and
- has obtained the majority (>50%) of total income from primary production in the last two years.

How do I apply?

Submit the one page application form to Northern and Yorke Landscape Board's Team Leader Kate Pearce as soon as possible and a Landscape Officer will be in touch to provide support through this simple process.

How can I spend the grant?

The funding can be used for:

- Constructing new or upgrading an existing stock containment area, such as fencing, gates, troughs, piping, tanks; pumps and basic livestock feeders.
- Installing water infrastructure pumps, piping, tanks, troughs;
- Establishing fodder plantings and shelterbelts – tube stock, guards, stakes;
- Accessing decision making tools feed and soil tests, specialist dry times advice, soil moisture monitoring, weather stations, telemetry sensor equipment.

What is ineligible?

- Labor and in-kind costs
- Vehicles or associated travel costs
- Utilities and operating costs of the business - gas, electricity, rates
- Purchase and movement of livestock
 e.g. agistment and freight fees
- Purchase and movement of feed
- Retrospective reimbursements
