33.12	<p>Biosecurity Overview</p> <p>The Manager Landscape Operations provided an update on the recent activities undertaken regionally within the Biosecurity Team which included:</p> <p><u>HR:</u></p> <ul style="list-style-type: none"> • Compliance Officer will commence employment 27th October 2025. <p><u>Weeds</u></p> <p><u>Future Drought Fund: Biocontrol Project</u></p> <ul style="list-style-type: none"> • Nationwide Weed Biocontrol Network, a project led by the Centre for Invasive Solutions. • PIRSA and SA Landscape Boards are acting as enabling partners in the project rollout. • This initiative aims to trial mass rearing and release of new biocontrol agents targeting species such as boxthorn, Opuntia spp., horehound, sagittaria, and others. <p><u>Priority Weed Communications</u></p> <ul style="list-style-type: none"> • District-specific priority weed posters have been completed and are currently being deployed in the North East region. • The North East Pastoral Community Landscape Officer has arranged for signage to be installed at shelters near the Olary public toilet stop and the Yunta Telecentre and A4 posters printed copies are displayed at the Olary Hotel and Yunta Telecentre <p><u>SA Pest and Weed Conference</u></p> <ul style="list-style-type: none"> • Three SAAL Biosecurity staff attended the 7th South Australian Weeds & Pest Animals Conference held in Adelaide. <p><u>SAAL Preferred Weed Supplier Panel</u></p> <ul style="list-style-type: none"> • The SAAL Biosecurity team has successfully overseen a public tender process to establish a three year panel of preferred weed contractors to support the Native not Noxious project. <p><u>Roadside Weed Control Collaboration</u></p> <ul style="list-style-type: none"> • Service Level Agreements (SLAs) and project plans have been finalised for Department for Infrastructure and Transport (DIT) funded roadside weed control projects. • This cross-regional collaboration between the Northern and Yorke and Eyre Peninsula Landscape Boards represents a \$300,000 investment in coordinated buffel grass management. <p><u>Buffel Grass</u></p> <p><u>ARTC Strategic Plan for Management of Buffel Grass in the Rail Corridor</u></p> <ul style="list-style-type: none"> • The Australian Rail Track Corporation (ARTC), has circulated their Draft Strategic Plan for Buffel Grass to SAAL, as well as to the Northern & Yorke and Hills and Fleurieu Landscape Boards, requesting feedback ahead of broader public consultation. <p><u>Buffel Grass Control</u></p> <ul style="list-style-type: none"> • SAAL are collaborating with NPWS in the Gawler Ranges region to control Buffel Grass on Kingoonya/Lake Everard Road to reduce source of infestation and spread into the Gawler Ranges and Eyre Peninsula region. <p><u>Pest Animals</u></p> <ul style="list-style-type: none"> • Reports of a deer sighting in the Quorn pass with monitoring cameras installed. • Reports of feral pigs breeding, spread and the associated impacts continue across the North East Pastoral region. • Monitoring cameras have been redeployed around permanent springs in the Wilochra and Boolcunda catchments for Feral Pig surveillance. • Aerial control operations are scheduled to commence in early November, with a follow-up program planned for May 2026 within the Coongie Ramsar footprint. • SAAL has secured additional funding through the Landscape Priority Fund (LPF) for two further aerial control programs targeting large feral herbivores. The first of these is planned for early December in the Oodnadatta region, where landholders have reported feral donkeys, camels,


