Ways in which the functions of the board affect members of the public

The SA Arid Lands region covers more than half of South Australia, taking up the state's north-east comer to its borders with New South Wales, Queensland and the Northern Territory. The board is a group of community, state and local government members who make decisions about regional investment in landscape management, with income derived from landscape levies, in conjunction with the Regional Landscape Plan. In 2021/22, the board has a newly developed SA Arid Lands Regional Landscape Plan. This plan is consistent with the State Landscape Strategy with the priorities of climate ready region, water management, sustainable land management, protecting and enhancing biodiversity and people and partnerships being shaped by both the requirements of the Landscape SA Act 2019 and the community's aspirations.

Public participation

The board can only achieve its goals by working in partnerships with industry groups, schools, community groups and volunteers. Partnerships extend the benefits of our investment and empower our community to contribute to the sustainability of the region's natural resources. The Grassroots Grant program enables volunteers and not-for-profit organisations to enhance their role in managing natural resources, and is administered by the board for on-ground projects in the SA Arid Lands Region. The board undertakes genuine community consultation and develops key partnerships to ensure the values and concerns of the community are reflected in planning and program delivery.
