3. MPLAG Chairs meeting with Minister for Environment and Conservation

The Chair quoted the Minister's opening address, "The commercial and recreational use of the marine environment is critical to the future of the regional communities and will not be unduly impacted by the marine parks". The Minister also said that it was not pertinent to set formal targets for the Sanctuary Zone size or percentage coverage but the government has committed to a comprehensive, adequate and representative system of marine parks that would meet the requirements national and international standards.

- 3.1. MOTION: The preliminary zoning scenario of 25% sanctuary area was too big, given previous expectations. Moved: Tom Tierney; Seconded: Greg Palmer The vote count was 8 (for) to 2 (against) and the motion was passed.
- **3.2. ACTION:** Overlay the 5A and 5B maps, and DENR to consider whether the data collected by the Prawn By-catch Report by David Curry of SARDI (Currie et al. 2009 the Prawn By-catch Report 2009) would be useful to provide information in the north east of the park. Moved: James Brooks; Seconded: Paul Frederick Harrison.

General Discussion

The Chair with the consensus of the MPLAG members wanted it to be made known that a lot of the information given in the SAMPIT's data collection during the 2nd MPLAG meeting has been followed to a certain degree but it was disappointing to see that some of the data provided at the last meeting appears to have been ignored in determining the current preliminary Sanctuary Zones.

Greg Palmer highlighted that the "Convention on Biological Diversity" states that the new target for 2020 is to have 10% of marine areas protected and under management, not necessarily as Sanctuary Zones. Australia's commitment to 10% of it's marine areas as protected is not a mandatory unless there is specific Commonwealth legislation to that effect (and there isn't), and in measuring Australia's progress in this matter and taken into account all protected areas including seasonally closed areas under various fisheries acts, protected areas and all State and Commonwealth government legislation."This information comes from the verbal advice given by the CEO of DEWHA, courtesy of the Commonwealth Fisheries Association.

4. Preliminary Sanctuary zone Scenario

The presentation highlighted the findings of the feedback that have been received from the marine park engagement program. The information/feedback has been plotted on the preliminary sanctuary zone maps and presented for discussion.

This is the first step of the process, the discussion with the MPLAG and the second is the public consultation where the zoning would be closer to the mark. This will be accompanied with the economic impact statements.

5. Group preliminary sanctuary zone scenario session

The MPLAG members and the gallery were given the preliminary sanctuary zone scenario maps and the Sanctuary Zone Checklists. The MPLAG members and the gallery decided to split into various groups representing various sectors of the community to review these items and contribute further to the refinement of the preliminary sanctuary zones.

The findings from the various groups compiled and then plotted on single maps as feedback data from this MPLAG meeting. The Executive Officer (Simon Clark, DENR will continue to receive all related information from the community's feedback through the MPLAG until the 28th January, 2011.

The following notes were recorded:

- 1. Remove a square section in the middle of Zone E as it is highly important for commercial and recreational fishing. This would include removing Hareby, Blyth, Smith and Dalby Islands. The centre portion of the Sir Joseph Banks Group is extremely important for both recreational and commercial scale fishing.
- 2. Remove part of the sanctuary zone on salt creek beach (Zone B) and include a 2km buffer from Cape Lalande north. This area within the proposed buffer is important for recreational fishing and commercial line scale fishing. Many people also added that they thought the northern boundary should be extended to include Lipson Cove and Lipson Island.
- 3. Once Zone A and B are reduced (notes 7, 8 and 12), extend the northern boundary of Zone B to the marine park boundary, extend Zone B east to Zone A.

The sardine industry also suggested to enlarge B and reduce A.

- <u>4.</u> Include a sanctuary zone off of Spilsby Island running from the eastern tip out the park boundary and from the southern tip, running in a SSE line from the tip to the park boundary. This area is a trade off for the middle section of the Zone E (note 1 above). However the Rock Lobster industry was not happy with this suggested zone. The remaining waters surrounding Spilsby Island are important for Charter and commercial fishers.
- 5. The waters surrounding Kirkby Isand (Zone E) are important for commercial scale fishing.
- <u>6.</u> Add an L shape coming east from Zone D (Point Bolingbroke) and then south to join up with Zone F as a trade of for most of Zone E. Although this was suggested by a few people, it was made clear that this area was also important for A class commercial fishers.

There was also a suggestion to decrease Zone D and move the southern boundary north approximately 1km as the area is important for recreational and commercial A class fishers.

- <u>7.</u> There is prawn fishing in Zone A in the area north of 34° 20′ 0° S and east of 136° 38′ 0 ° E, so remove this section of Zone A.
- 8. There is no prawn fishing in Zone A in the section below 34° 20′ 0° S and east of 136° 38′ 0 ° E.

There is prawn and sardine fishing below Zone A.

9. Remove the eastern section of Zone E from East of Hareby and Blyth Islands and trade off for comment 6. Commercial scale fishing in the area.

Remove the north western corner of Zone F from Sibsey Island up as this is an Important area for commercial whiting. A class fishing in the area. A commercial charter operator uses Sibsey and English Islands due to their proximity to Port Lincoln. This operator also uses the waters between Duffield Island and Stickney Island.

- <u>10.</u> Remove the western half of Zone E (Dangerous Reef) as this area is important for charter operators. This half could potentially be moved to the east, keeping the zone a similar size. Alternatively, the sanctuary zone could cover the existing Dangerous Reef area of the Sir Joseph Banks Conservation Park which would mean a fixed distance surrounding the reef.
- <u>11.</u> There is a boat ramp at Second Creek which is not on the Atlas Map.
- <u>12.</u> Zone B is too large, although the dog leg portion is not used much. Suggestion to remove this portion of the zone and alternatively lengthen Zone B to meet Zone A.

7. Marine Park Issues and Strategies Update

The Marine Park Management Plan is a requirement of the Marine Parks Act. The marine parks will be managed in accordance with their respective management plans. These management plans will ensure that the marine parks achieve the required standards of conservation and use of resources by community and industry consistent with the multiple use marine parks. There are two components to the management plan:

- (a) strategies for the management of the park,
- (b) the zoning arrangements

The MPLAG members play a major role in providing the information for both these components. In the 2nd meeting the MPLAG members were asked to provide information on the local knowledge and issues relevant to SJBMP. The information gathered has been incorporated with the information researched by DENR staff from various other sources as part of the strategies for the management of this marine park.

DENR is now asking the MPLAG members to provide the local knowledge on the possible Sanctuary Zones as the second component of the management plan and these will be refined over the next couple of meetings.

A Notice of Intent to make the management plans has been published by the Minister, dated 8th November, 2010. It is now official that the journey has begun and by mid 2012, the management plans for the marine parks must be approved. Under the Marine Parks Act, the Minister must, as soon as practicable after the establishment of a marine park commence the process for the making of a management plan with a view of completing the management plan within 3 years of the proclamation of the marine park.

8. Questions from the gallery

8.1. Meeting clashes

The meetings between the various industries should be spaced out so to prevent clashes of meetings, as some members attend more than one meeting representing various other groups.

8.2. Compensation and Minister's commitment

The previous Minister's commitment to having a formula for calculating displaced effort agreed upon prior to MPLAG meeting 3 was discussed. Most were very

unhappy that this had not been achieved. Commercial fishers were not convinced that they were in fact going to be paid compensation. Compensation or lack of for the Ancillary Support Groups and the Recreational Fishermen's Association was also discussed.

8.3. <u>PIRSA & SARDI</u>

Lack of involvement of PIRSA and SARDI personnel in the marine parks meetings.

8.4. 5% Economic Impact

A concern that the formation of the marine parks would cause an economic impact of more than 5 % on commercial fishers.

9. Record of meeting – 18th November, 2010

Sir Joseph Banks Group Marine Park.

- Preliminary sanctuary zone scenarios in the Sir Joseph Banks Group Marine Park were presented as a starting point for discussion.
- Comments were:
 - 1. General discussion about the size of the sanctuary zones is a key issue, considered too large. Lack information backing the size of the zones. Motion recorded in Minutes.
 - 2. Suggestions of possible zoning discussed and alternatives put forth, not in place of 25 %.
- Issues:
 - 1. Size of the sanctuary zones is a key issue, considered too large. Lack information backing the size of the zones. Motion recorded in Minutes.
 - 2. Commitment from MPLAG members to go back to their community networks to discuss the possible sanctuary zones and provide feedback.
