MINUTES

The third meeting of the West Coast Marine Park Local Advisory Group (MPLAG) was held at 4:30 pm on 16 November 2010 at the Port Kenny Sports Club, Flinders Highway, Port Kenny

Trevor Gilmore moved that the minutes of the second meeting are accurate, seconded by Greg Schreiber.

- Trevor Gilmore raised concerns relating to draft regulations for proposed sanctuary zones not including any restrictions regarding anchoring in no take zone. He is concerned anchors can potentially do significant damage to the marine environment. Suggestions of anchor points or mooring.
- Draft regulations further discussion ensued, the notion of a possible permit system was raised. There was some ambiguity relating to recreational / commercial diving and 'no take' a misunderstanding of the draft regulations. Regulations are still in draft form and will most likely not be passed through Parliament until next year.
- Threats and issues to be included in the management plans were discussed at DENR workshop. Management plans will be finalised and ready for public consultation in 2011.

- Future funding, specifically related to compliance and monitoring was also raised. Concerns were voiced about DENR's ability to enforce restrictions aligned with implemented sanctuary zones.
- Restricted access zones were discussed and explained that they would be of a small size.
- Noel Box suggested sanctuary zones should be considered where an aquatic reserve (under the Fisheries Act) already exists already declared at Nicholas Baudin Island.
- There were frustrations around the Government commitments to accommodate existing haul net fishers in Spencer Gulf, whilst the West Coast appears to have been left off the Governments Commitments document.

3. MPLAG Chairs meeting with Minister for Environment and Conservation (Trevor Gilmore)

Trevor advised that the Minister met with all Chairs throughout SA, and though 1.5 hours were allocated, the Minister spent 2.5 hours with the group. The Minister wasn't in a hurry to leave and is happy to discuss issues.

The Minister's opening address reinforced that this process was not about percentages; though this seems to be the common perception. Environment and habitat protection are the objectives of marine parks. The low population base adjacent to the marine parks on the west coast, in comparison to other regions, was highlighted. Displaced effort was discussed and is still unresolved.

General agreement that it is a challenging process but progressing well. WC MPLAG is ahead of other MPLAG. Meeting with Chairs important & productive. Regional DENR staff are providing good service to Chairs and members of MPLAGs.

General discussion

- The overall aim of this MPLAG is to get it right, and provide valuable advice, along with industry groups and environmental groups to the Minister for Environment and Conservation.
- There is some discussion about processes to measure the economic impact (with specific reference to the Government commitment of less than 5% economic impact) of zones across the entire industry sector, which could help the group with zoning advice.
- Tony Custance was concerned about the compounding economic & social impacts if displacement is not managed properly, namely; economic impact to workers, people could lose jobs, supporting industries could also suffer which would lead to a flow on effect in local communities.
- Jonas Woolford explained that in relation to displaced effort any holder of statutory authority is entitled to compensation.
- Noel Box expressed that he is feeling very uncomfortable with this displacement effort without regulations in place he feels it is difficult to progress.
- Simon Clark reiterated that flow on effects will be considered in the economic impact statement, which is to be developed as the process evolves.
- Trevor Gilmore was also uncomfortable going into these discussions where there is no guarantee of compensation and would like the Minister to deal with this.
- Simon Clark outlined the 4 steps / principles in the process of displaced effort compensation Trevor Gilmore expressed relief that a concrete process was in place, however would like to see this in writing from the Minister.
- Trevor Gilmore expressed concern that potentially areas which are desirable to protect are generally going to impact on abalone, lobster fisheries where the fish aren't transient.

4. Preliminary Sanctuary zone Scenario

Simon Clark presented information leading up to discussion around the possible sanctuary zone scenario. He reiterated that this was a starting point only. Some of the discussion included:

• Atlas maps "Wetland" where members disagreed with the fact that Point Labatt was proclaimed a wetland.

ACTION:

DENR to provide a link to MPLAG members of the Commonwealth website that explains the declaration of wetlands.

- Discussion about the validity of the Sea Surface Temperature maps.
- MPLAG members also disputed the benthic habitats map, suggesting that the waters in Sceale Bay are rocky habitat not soft sandy habitat.
- MPLAG members were of the opinion that the seabirds & coastal waders data is inaccurate.
- Boat ramp at Sceale Bay not recorded on Boat Ramp map.

Discussion on changes to sanctuary zones marked on map.

5. MPLAG initial advice to DENR

There were multiple suggestions made on the current scenario and a variety of views from MPLAG members. Views were captured on the map. A summary is a follows:

Park 3

- 1. Salmon and mullaway fishing at "Paddy's hole".
- 2. Smooth Pool as a possible sanctuary zone as it provides a diving opportunity from the coast.
- 3. Need buffer at top part of zone A, as there is commercial scale fish netting activities and recreational fishing.
- 4. In possible zone A, sandy habitat extent.
- 5. Boat ramp in this location.
- 6. Beach launching location.
- 7. Move possible zone B south to Point Labatt, to reduce impact on recreational fishing, impact on commercial fishing is similar to Searcy Bay and Cape Blanch.
- 8. Heart Bay and western part of Searcy Bay are of high recreational use.
- 9. Suggested possible zone around Nicholas Baudin Island, including a strip along the lee side of Cape Blanche towards the settlement of Sceale Bay, as there is an important Australian Sea Lion breeding colony, coastal raptors and diverse reefs; it is also a high use area
- 10. Increase protection at Point Labatt, recognise that Industry abalone and rock lobster is high.
- 11. Possible zone D, move southern boundary north, Frenches' boat ramp, commercial and recreational use.
- 12. Some where represent the mouth of Baird Bay.
- 13. Some agreement with possible zone E.
- 14. Possible zone F, move western and eastern boundary closer together.
- 15. Move possible zone F west to avoid the "Slide".
- 16. A possible deep water zone suggested.
- 17. Possible zone B, location to Point Labatt, will pick up granite reefs and offshore area.
- 18. In possible zone F, there is 25-30 fathoms, deep limestone reef.
- 19. A possible sanctuary zone, to the south eastern side of Jones Island, following the inshore reefs on the North Western side to approximately 1 km to east and south.
- 20. And area south of Baird Bay considered to be high commercial rock lobster.
- 21. Flounder fishing and dabbing to the western end of Venus Bay in possible zone G.
- 22. A suggested location to represent habitat similar to Germain Island.
- 23. Move all of possible zone G east.

Park 4

- 1. Pearson Island, Southern Anchorage is a fishing area.
- 2. Possible zone B, bay to north of Flinders Island is a Cray boat anchorage area.
- 3. Potential zone to align with Kapara Wreck, a heritage site.
- 4. Possible zone B, high recreational and commercial effort.
- 5. Possible zone C preferred over Flinders possible zone B.
- 6. Location in suggested zone to south of Flinders and Top Gallant Islands, are commercial abalone and rock lobster areas, of lower impact.
- 7. Some agreement, refer to point 1.
- 8. Possible zone D, move south and buffer Lock's Well.
- 9. Possible zone E, some marine scale ok, lobster and abalone impacted, but lower.
- 10. Possible zone A, commercial rock lobster fishing through this zone.
