Discussion about *Terms of Reference* for SA's MPLAGs (distributed). Key points were discussed, covering the establishment, objectives and functions of MPLAGs.

#### 4.3. Community input - mapping

After the presentation, DEH shared the experience of the Encounter Marine Park MPLAG which was successful in resolving various issues pertaining to the zoning around Victor Harbor through the community input. DEH presented the South Australian Marine Parks Information Tool (SAMPIT). SAMPIT is an information gathering tool designed to allow the local community to provide information on the use of areas. Local knowledge will be used to complement scientific knowledge.

Hard copies of SAMPIT (Sir Joseph Banks Group Marine Park) were distributed. The process of populating and submitting the forms were explained. The members were also shown SAMPIT on the web which is found at <a href="https://www.marineparks.sa.gov.au">www.marineparks.sa.gov.au</a>. Online use of SAMPIT was encouraged where people have good internet access.

# 4.4. Community input - Marine Parks Values Statements

The MPLAGs' views and inputs are needed for the Sir Joseph Banks Group Marine Park values statement. This will help the development of the marine park management plans.

Values statements feedback forms were distributed to the MPLAG members with all forms due back by March 19, 2010. The results of the feedback will be discussed in the next meeting.

#### 4.5. Communication plan (Simon Clark)

MPLAG to collect information from the public via the SAMPIT They need to identify what information is to share, who it is distributed to, and by what method and when it will be done. Ideally the majority of the data is to be collected within 6 weeks of the 1st meeting.
