### 5.2. Sharing SAMPIT information

DEH provided a background to the SAMPIT data and presented the results from the information-gathering. The information presented on a chart for review by the members.

There were some points added:

- Greater fishing effort, relative to information detailed on SAMPIT charts, at the following locations:
  - o Northern area around Langton Is,
  - o More fishing at the "Sand Dune" than indicated on the chart.
  - o Eastern Roxby Island,
  - o The drop off north of Blyth Island, towards Reevesby Island.
  - o Area west of Spilsby Island,
  - o The Shoals in the western part of the park.
- Lower effort around Kirby and Dalby Islands.
- Lower effort at "salt creek," north of Tumby Bay.
- RFL (low platform reef) medium density fishing at Penny Shoal, lighter density fishing at Nicolette & Jane Shoal
- Australian Sea-lions at English Island
- Some shell collection (commercial) from Point Bolingbroke out to Quilty Rock and Secret rock.
- Kirby Island and Dalby Island are used less more exposed to the weather
- Medium to high use, W, N & NNE sides of Langton island
- The eastern side of Roxby Island should show Medium use.
- Duffield Island is more highly used than shown, and the area south of Duffield island should show Medium usage, but depending on the weather could be highly used.

- Blyth Island has Australian Sea-lions, sea urchins. Is, or could be, used for snorkelling and ecotourism.
- The beach just north of the current boundary is low use, with a mix of rocky/sandy mix beach and headlands.
- Should connect to Lipson Island
- The area just offshore from Cape Lalande to the northern border of the park is more heavily used by boats than shown. It gets medium to high use. Known as 'The Sandhills'
- The lighter coloured area of Tumby Bay (between the town of Tumby Bay and Salt Creek Beach) could be an alternative to Second Creek (Salt Creek).
- The northern side of the spit below the town of Tumby Bay is Medium to High use
- The bay west of Tumby Island is too tidal to be fished.
- There is heavy coral in the most northern of the sardine blocks.
- There is a Snapper fishery somewhere out in the far eastern arm of the park, where the depth changes.
- The majority of SAMPIT data appears to be from Tumby Bay based residents more use of the reef from fishers based in Port Lincoln

There was a general consensus that from a recreational fishing perspective, the SAMPIT data was a reasonably accurate reflection of the different intensity of effort in different areas in the Sir Joseph Banks Group.

## 5.3. Identifying local management issues

- DEH presented the background to developing the marine park management plans and the steps in the process. This included reviewing the objectives of the Act, the MPLAGs' role in the zoning scenario design, and identifying issues and opportunities for future management plans.
- Worksheets A-F (distributed) were explained in detail. The MPLAG members were asked to pass these to the various interest groups for their feedback. The deadline for feedback is 25<sup>th</sup> June, 2010.

### 5.4. Preparation for zoning

- DEH is developing a product that will assist the MPLAGs to self assess their application of the 14 design principles, generally on the fly. A checklist is currently being developed, which would be distributed to the MPLAG members later. Some sample questions on the checklist were also shown.
- DEH also presented the policy commitments from the Government that relate to the design of the parks. MPLAG members are not responsible for implementing the commitments; however, they are another level of information that needs to be considered in the process.

### 6. Record of meeting - 27th May 2010

Sir Joseph Banks Group MPLAG.

- MPLAG members reviewed SAMPIT data provided by DEH, recognising that
  most of the data presented was from the recreational fishing sector. The charts
  were reviewed and extra information was added. The group recognised that
  the commercial data would be received at a later date.
- Outline of the proposed management plan content.
- The main purpose of the marine park is representative habitat protection for future reference.
- Outline of the design process going forward was covered.
- A table for issues raised (summary) during the meeting to be presented in the meeting minutes.
- Guarantee provided to MPLAG members in relation to response to questions raised via correspondence.
- The key task prior to the next meeting was to identify local management issues, eg threats or opportunities for management.
