- Note 1 Under the National Parks and Wildlife Act 1972 and National Parks and Wildlife (National Parks) Regulations 2016, tour operators must hold a Commercial Tour Operators (CTO) licence when conducting tours in SA parks.
- Under the Commercial Tour Operator Licence Terms and Conditions, the payment of Park Entry and Camping Fees for tour Note 2 participants (including Tagalongs) is mandatory and agreed to by tour operators in their signed CTO licence application and forms part of the basis on which the licence is issued.
- Licensed CTOs identified as conducting tours in SA's Desert Parks ARE NOT REQUIRED to purchase a Desert Parks Pass for themselves, their tour personnel (e.g. bus drivers & tour guides) or their tour clients, including Tagalong participants.
