Note 1 Under the *National Parks and Wildlife Act 1972* and *National Parks and Wildlife (National Parks) Regulations 2016*, tour operators must hold a Commercial Tour Operators (CTO) licence when conducting tours in SA parks.

Note 2 Under the Commercial Tour Operator Licence *Terms and Conditions*, the payment of Park Entry and Camping Fees for tour participants (including Tagalongs) is mandatory and agreed to by tour operators in their signed CTO licence application and forms part of the basis on which the licence is issued.

Note 3 Licensed CTOs identified as conducting tours in **SA's Desert Parks ARE NOT REQUIRED** to purchase a Desert Parks Pass for themselves, their tour personnel (e.g. bus drivers & tour guides) or their tour clients, including Tagalong participants.
