- c) DEW shall be entitled to charge interest on all amounts not paid by the due date for payment and the Customer undertakes to pay any such interest charged. Interest shall be calculated at a rate not exceeding 2% per month.
- d) Any expenses, costs or disbursements incurred by DEW in recovering any outstanding monies, including debt collection agency and Solicitors fees, shall be paid by the Customer.
- e) DEW shall be entitled to terminate without notice any credit arrangement with the Customer in the event of non-compliance in any of the terms and conditions contained herein.
- f) Any subsequent reinstatement of credit arrangements will require payment of the fees applying to a new application.
