(a) it demonstrates important aspects of	The Australian Education Union (South Australian Branch), formerly the
the evolution or pattern of the State's	South Australian Institute of Teachers (SAIT), is a union—a collective of
history	education workers who organise through democratic structures to advocate for professional and industrial interests. The power and legacy of the AEU(SA) do not reside in a particular building or site, but in the members themselves and their collective actions. Important milestones in the union's history occurred across various locations, not only at Greenhill Road. The assertion that this site alone encapsulates the evolution of the education union movement in South Australia overstates its significance in the broader pattern of union and education history. Moreover, the current site and the colonial-era building adjacent to it represent a period of Aboriginal dispossession. Any future development of this site offers the opportunity to engage meaningfully with Kaurna Elders to restore cultural identity and presence to this land, reflecting a more inclusive understanding of the State's evolving history.

(d) it is an outstanding representative of a particular class of places of cultural significance	While 163 Greenhill Road is one example of brutalist architecture in South Australia, it is not an outstanding or unique representative of this class. Numerous more prominent or well-preserved examples of brutalist architecture exist across Adelaide, including civic and institutional buildings in the CBD. Many of these are of greater public visibility and architectural integrity. Furthermore, other sites hold deeper cultural significance for the education community—for example, 31 Flinders Street, and the Regency TAFE campus—all of which have hosted critical activity in public education and training over decades. The case for heritage listing based solely on architectural typology is therefore weak when compared with these broader and
(e) it demonstrates a high degree of creative, aesthetic or technical accomplishment or is an outstanding representative of particular construction techniques or design characteristics	more representative examples. The building at 163 Greenhill Road may reflect elements of brutalist design, but it does not reach the threshold of "outstanding" as required by this criterion. Its current state is one of poor maintenance and functional decline, and it lacks the distinguishing design characteristics or construction innovations that would mark it as a leading or exemplary work of its type. Further, there is limited public visibility or accessibility to the building's features that might contribute to its aesthetic appreciation by the broader community.

(f) it has strong cultural or spiritual associations for the community or a group within it

Unions derive their cultural significance not from physical locations but from the actions and collective efforts of members across generations and sites. The AEU(SA)'s cultural identity is linked to its campaigns, its members, and its work in schools and communities throughout South Australia—not any particular headquarters. Moreover, decisions about the future of 163 Greenhill Road have been made collectively by union members over a number of years. These discussions have involved consultation, deliberation, and a clear democratic mandate to pursue a new future for the organisation, principles that reflect the heart of unionism. Imposing a heritage listing now, against the will of members, undermines the cultural and democratic traditions of the union itself. Imposing a heritage listing on the building against the democratic will of members risks creating serious financial and governance burdens. The building is currently in a state that requires significant maintenance and modernisation. A heritage listing would introduce constraints that may render necessary renovations cost-prohibitive. If the union is unable to bring the building to a usable standard under these restrictions, it may be forced to relocate—leaving a listed building vacant and underutilised. Such an outcome would be neither economically responsible nor consistent with sound heritage stewardship.
